Dear Colleagues:

The CSS Policy and Procedures Manual has recently been updated to include the following changes:

- (1) Policy surrounding the use of civil contempt as an enforcement remedy under 45 CFR 303.6 has been clarified and revised because of the Final Rule published on December 20, 2016. Changes include revision of the Show Cause document to incorporate the federal requirement to notify non-custodial parents that his or her ability to pay constitutes the critical question in the civil contempt action. Policy is also included regarding the federal requirement to screen for the non-custodial parent's ability to pay and provide such information to the court for use in determining a purge amount and/or purge conditions. This policy was effective February 21st, 2017, and is found in Chapter P, Topic 20, Section B of the Manual.
- (2) Policy on the use of administrative enforcement remedies has been moved to Chapter P, Topic 02, Section D.
- (3) New policy has been added allowing the non-custodial parent to sign a document for early release of Financial Institution Data Match (FIDM) account funds. The document is titled, "Affidavit for Release of FIDM Levy" and is available on SharePoint. This policy can be found in Chapter P, Topic 10, Section F- Early Release of FIDM Account Funds. Information regarding the document can be found in Chapter W, Topic 7, Section E-Affidavit/Release FIDM Levy.

- (5) The 2017 Poverty Guidelines have been added. This information can be found in Chapter B, Topic 04, Section C.
