# DEAR COUNTY DIRECTOR OF SOCIAL SERVICES

#### SUBJECT: Challenge for Children, 2000 - End of Year Reports and Challenge for Children, 2001 - Time to Make a Commitment

We have just completed the fourth year of the **Challenge for Children**. During calendar year 2000, ninety-one (91) county Departments of Social Services accepted the **Challenge for Children, 2000** to make reduction of the foster care backlog a top priority. All participating DSS agencies were formally recognized and thanked at the Children's Services Conference in March. These county agencies also received invitations to participate in a number of special training opportunities held across the state.

It is now time for the county DSS agencies that participated in the **Challenge for Children**, **2000** to submit their year-end backlog information. <u>Backlog is defined as</u> <u>those children who have been in the custody or placement responsibility of a county</u> <u>Department of Social Services for more than 12 months, regardless of their current living</u> <u>arrangement (i.e., placement.</u>) In other words, the children in your backlog as of January 1, 2001, will have entered the custody or placement responsibility of your agency prior to January 1, 2000. Included with this letter is information that the Division received from you in early 2000 identifying the children in the foster care backlog on January 1, 2000. Please review the information carefully, striking through the name of each child that left the backlog during 2000 along with the reason the child left, (adopted, returned to parent, kinship care placement, etc.), and making changes in the custody status, age, name spelling, gender, race, etc. of any remaining children. <u>Please also identify those youth</u> who are 18 years of age or older and remain in foster care pursuant to a Voluntary <u>Placement Agreement (VPA)</u> so that they can be deducted from the official backlog count. This is done by placing an "X" in the VPA column.

County DSS agencies that participated in the **Challenge for Children**, **2000** should use the attached "**CHALLENGE FOR CHILDREN 2001**" form to identify any <u>additional</u> children (i.e. not remaining on the original list) who are in the foster care backlog on January 1, 2001. The data will be compared to the data submitted in January 2000, in order to determine the percentage of change in your backlog over the past year. County DSS agencies that did <u>not</u> participate in the **Challenge for Children**, **2000** but want to

participate in the **Challenge for Children**, 2001 should use the attached "**CHALLENGE FOR CHILDREN 2001**" form to identify <u>all</u> children in the foster care backlog on January 1, 2001.

In addition to the county-specific backlog information for January 1, 2001, <u>all</u> county DSS agencies that want to participate in the **Challenge for Children**, 2001 must submit an agency-prepared statement of acceptance of the **Challenge for Children**, 2001 and the attached "vision" for the child welfare system, bearing the signatures of the agency Director and <u>all</u> of the agency's child welfare social work and supervisory staff (including IFPS, CPS, Foster Care, and Adoptions).

County DSS agencies with the most significant backlog reduction will receive special recognition.

This is a most important challenge that we hope <u>every</u> county DSS will accept for 2001. Thank you for your consideration of this challenge. I want to personally commend all of the counties that participated in the **Challenge for Children, 2000**, and especially those counties that have participated for the past four years. Your willingness to accept the **Challenge** and the success that you have experienced are now receiving national recognition as a part of the child welfare reform effort.
