## Subject: Changes in the Children's Services Training Calendar

The purpose of this letter is to communicate with county staff regarding changes in the Winter and Spring, 2001 NCDSS Children's Services Training Course Schedule. As you are aware, hiring and travel has been restricted for state employees due to the current budget situation. As a result, we have canceled all the Pre-service training dates at the Fayetteville Regional Training Center scheduled from March 20, 2001 through June 30, 2001. As usual, we will continue to offer the Pre-Service training at the Asheville, Charlotte, Greensboro and Kinston Centers. Please review the Winter and Spring , 2001 NCDSS Children's Services Training Course Schedule to obtain those dates. Also, noted below we have canceled and revised the dates of some other training events as courses lacked the minimum number of registrations for the class.
