### **On-Campus Housing for Norht Carolina DSS Staff**

Forty rooms in Ruffin Hall on UNC Chapel Hill's North Campus have been reserved for North Carolina DSS staff use June 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> (Wednesday-Friday nights). The cost is \$36.00 per night per room. All rooms have two single beds. Participants may choose to share a room or stay by themselves.

Linens for each bed (2 sheets, 1 towel, 1 pillow), blanket, and a telephone will be provided for each room. Showers and restrooms are located on each floor (rooms do not have a private bath). Ruffin has a kitchen area, vending and ice machines, mail boxes, computer/cable TV outlets, and parlor/lounges/TV rooms, and is air-conditioned.

Check-in will take place at Ruffin on June 6<sup>th</sup> for participants that wish to attend the skills-building institutes and on June 7<sup>th</sup>. Check-out will be in the morning of Saturday the 9<sup>th</sup>.

Ruffin is located approximately one mile from the Carolina Inn. Participants that choose to do so may access the free campus shuttle to get to and from the Carolina Inn.

On-campus parking is limited and requires the purchase of a parking pass. Campus parking passes may be obtained for \$2.00 per day or \$5.00 per week. There is a limited number of parking spaces located across the street from Ruffin in the Cobb parking area. Daily and overnight parking on Stadium Drive will also be available for Ruffin occupants and other conference participants.
