The Division in partnership with Caldwell County Department of Social Services is extending an invitation to all **Challenge for Children** Counties to attend a day of training on **Tuesday, December 11, 2001**. This **Challenge for Children** event will introduce participants to Minnesota's "Alternative Response System".
