PURPOSE

As a strategy within North Carolina's Diligent Recruitment and Retention (DRR) Plan, the Division of Social Services will once again be hosting quarterly diligent recruitment and retention peer-topeer calls. In order to improve statewide efforts of recruiting, retaining, developing, and supporting a pool of families who can meet the needs of children and youth in foster care, NC Kids will provide a range of resources, events, and activities throughout the year, including quarterly calls. These calls will provide an opportunity for county child welfare agency and private child placing agency staff to come together to discuss and share innovative ways for recruitment and retention of foster, adoptive and kinship families. The focus of the calls will serve as a support for areas such as family response and engagement, family capacity development and support, and increasing the number of licensed kinship placements.

These calls are intended as a forum for front line staff and supervisors to learn from and discuss with their peers across the state different aspects of diligent recruitment and retention. For the upcoming year, the calls will occur in **January, April, July, October and December**. Please join us on these calls to gain valuable resources, tools, and peer-to-peer support to improve permanency outcomes.
