DEAR COUNTY DIRECTORS OF SOCIAL SERVICES

SUBJECT: TRIPLE P SURVEY

REQUIRED ACTION: TIME SENSITIVE

The purpose of this letter is to (1) describe the purpose for the North Carolina Triple P Landscape Survey for County Child Welfare Agencies, (2) provide the link to the survey with a supporting reference document, and (3) request completion of the survey by February 8, 2019.

BACKGROUND

In CWS-01-2019 sent on January 3, 2019, the Division of Social Services (DSS) provided an update to the statewide scale-up of the Triple P – Positive Parenting Program system of interventions and described the investments being made by DSS and its state partners in building an infrastructure to support effective implementation of Triple P. In that letter, DSS also indicated that a survey would be forthcoming about the use of Triple P in your agency.

As previously noted, data from Triple P America shows that county child welfare workers are among the highest population to have received Triple P training in North Carolina. Many county child welfare agencies are interested in delivering Triple P or are delivering Triple P with families either directly or by referring to trained private providers whereas others have experienced barriers to delivery due to staff attrition and other child welfare priorities.

The approach being taken by DSS and its state level partners, based on research and practice, teaches that the Triple P system is most effective when there is strong community, service agency and practitioner capacity to support the delivery of the Triple P system of interventions. When capacity at each level is present, Triple P implementation dramatically improves as does the potential for long term success --- both in terms of speed in adopting and delivering Triple P, as well as *how well* Triple P is delivered within agencies.

Results of this survey will be used by DSS and its state partners in its Triple P strategic planning efforts which includes a focus on resources needed at the state, community, agency and practitioner levels to support the unique implementation needs of Triple P in county child welfare agencies.
