SUBJECT: MANDATORY CIVIL RIGHTS AND MULTI-ETHNIC PLACEMENT ACT (MEPA) TRAINING

REQUIRED ACTION: TIME SENSITIVE

North Carolina Division of Social Services in partnership with US HHS Office of Civil Rights (OCR) will be hosting a Civil Rights / Multi-Ethnic Placement Act (MEPA) training. This training will be offered in person and through a live webinar. The training will be held on **Tuesday**, **February 26, 2019 from 9:00am – 4:00pm.** The in-person training will be held at **Guildford Technical Community College, Greensboro Campus; 3505 East Wendover Ave., Greensboro, NC 27405**.

US HHS OCR requires mandatory participation by all 100 counties with at least one representative (Director, Child Welfare Program Administrator or Program Manager) from each county participating either in person or on the live webinar. This is the rescheduled training in place of the Civil Rights / MEPA workshop that was planned for the Social Services Institute in October 2018. As you may recall, the Social Services Institute was canceled due to Hurricane Florence.

This training will focus on federal civil rights laws for child welfare including MEPA law and how it is applied to child welfare services. NC Division of Social Services will also provide an overview of the updated template for localized Diligent Recruitment and Retention (DRR) Plans which includes MEPA requirements.
