SUBJECT: SAMPLE MOA FOR REQUESTING JWISE REPORTS

This letter is to inform you that the Administrative Office of the Courts (AOC) has developed a sample Memorandum of Agreement (MOA) for requesting data from JWise locally. In light of increased requests for child welfare data, AOC has revised its policies and procedures regarding how these requests will be handled. It remains the policy that reports that have previously been generated by AOC staff can be requested and will be provided to the requestor in accordance with North Carolina Public Records Law. Any confidential information will be redacted from these reports before dissemination. However, AOC staff is not obligated to provide reports that *have not* been previously generated, even if the reports can be generated by JWise. Several reports are available in JWise and upon execution of a Memorandum of Agreement with local stakeholders for sharing JWise reports, they can be obtained locally by those with approved access to JWise (e.g., Juvenile Clerks, GAL staff). The following reports are available:

- NC Key Time Standard Adjudication Hearings Report
- NC Key Time Standard Disposition Hearings Report
- NC Key Time Standard First Permanency Planning Hearings Report
- CIP Report for Measure 1-Time in Median Days to First Permanency Hearing

- CIP Report for Measure 3-Time in Median Days Permanency Achieved
- CIP Report for Measure 4-Time in Median Days to First TPR Filing
- CIP Report for Measure 5-Time in Median Days to TPR Order Entered
