ATTENTION: DIRECTORS, CHILD WELFARE PROGRAM ADMINISTRATORS, MANAGERS, SUPERVISORS, AND SOCIAL WORKERS

SUBJECT: USING THE CHILD MEDICAL EVALUATION PROGRAM (CME) & CHILD AND FAMILY EVLAUATION PROGRAM (CFEP) NEW POLICY

REQUIRED ACTION: Information Only I Time Sensitive – *Effective Date 12/1/2020* Immediate

PURPOSE

The Division is committed to providing counties with resources to support assessment of child maltreatment reports and to improve safety outcomes for children. This includes the improvement of programs and policies such as the Child Medical Evaluation Program (CMEP) and the Child and Family Evaluation Program (CFEP). In coordination with the Child Medical Evaluation Program administered by the University of North Carolina at Chapel Hill (UNC-CH) School of Medicine, representatives from county child welfare agencies and the Division, protocol and guidance has been revised.

Revised manual sections include: **CPS Family and Investigative Assessments:** Using the Child Medical Evaluations Program (CMEP)/Child and Family Evaluation Program (CFEP): protocol and guidance.

The additional protocol and guidance provide workers a comprehensive overview of the CMEP/CFEP, and when to use the CMEP/CFEP. Significant protocol changes are the local child welfare agency must refer children for a CME or CFE *under certain circumstances* and there is no override of this requirement. These are spelled out in the **CPS Family and Investigative Assessments** manual.

The Consent/Authorization Form for Child Medical and Child/Family Evaluation, DSS-5143, has been updated and instructions for the completion of the form are now provided.
