PURPOSE

The purpose of this letter is to inform county child welfare agencies of upcoming training opportunities regarding the human trafficking policy changes necessitated by recent legislation. The policy will be effective on October 1, 2018.

The Division, in partnership with the University of North Carolina at Chapel Hill School of Social Work and Project NO REST, will offer four live webinars to child welfare workers, supervisors, and program managers to prepare the workforce for this implementation. The content of each webinar will be the same and will include an overview of human trafficking laws, a discussion of the policy changes, and practice guidance.
