SUBJECT: Kinship Training, Caring For Our Own

North Carolina Division of Social Services has partnered with Children's Home Society of North Carolina to offer *Caring For Our Own*, a kinship training support opportunity for relatives and fictive kin caring for children in foster care.

Caring For Our Own is a kinship program tailored to the needs of relatives and fictive kin caring for children in foster care. The program uses a strengths-based approach in identifying resources available to kinship families. Kinship caregivers caring for a child in DSS custody are eligible to receive financial and other supports once they are a licensed foster parent. Through a series of ten online meetings, the 27-hour Caring For Our Own kinship program combined with 3 hours of NC DHHS approved content meets the 30-hour preservice training requirement for foster home licensure. Participation in this program provides kinship caregivers with assistance and ideas for working in partnership with the helping network, the children and the birth parents.

During the last fiscal year there were nearly 2600 children placed with kinship caregivers. However, less than 4% of these relative placements were licensed. North Carolina wants to increase the number of kinship caregivers who become licensed in order to achieve safe and timely exits to permanency.

To accomplish this, DHHS has partnered with Children's Home Society of North Carolina to offer four upcoming Caring For Our Own groups online beginning January 2021:

Thursday nights, January 7 - March 11 / 6-9 pm Monday nights, January 11 - March 15 / 6-9 pm Tuesday nights, January 19 - March 23 / 6-9 pm Tuesday nights, January 28 - April 1 / 6-9 pm
