SUBJECT: SURVEY ON CONTINUANCES IN THE COURT SYSTEM

The North Carolina Division of Social Services (NCDSS) is interested in addressing court delays in order to achieve timely permanency for children and youth. Our state's 2007 Program Improvement Plan includes strategies aimed at collaborative work between courts and agencies. As a result of state level collaboration between NCDSS leadership and leadership from the Administrative Office of the Courts (AOC), it has become apparent that there are judicial districts or counties within judicial districts experiencing issues with continuances. NCDSS, the Program Services Division of AOC, the state Guardian ad litem (GAL) program, and the Office of Indigent Services (IDS) are working together to reduce the number of continuances in abuse, neglect and dependency (AND) and termination of parental rights (TPR) cases. From data collected by the state GAL program, it appears that in FY 2007-2008 there were 22 counties where AND and TPR hearings had a continuance rate higher than 40%.

As an effort to identify some of the barriers or practices that are causing continuances in these 22 counties, we have developed a survey for county child welfare staff, district court judges, juvenile clerks, GAL attorneys and staff, DSS attorneys and staff, and parent attorneys.

The results of the survey will be shared with each county. It is our hope that the information will enable each county to develop local solutions that will help reduce the number of continuances in AND and TPR cases.
