SUBJECT: Transportation Really Is Possible (TRIP) – NC's Driver's License Pilot Project

The purpose of this letter is to announce the launch of, and provide information about, North Carolina's Driver's License Pilot Project – Transportation Really Is Possible (TRIP). For many young people in foster care, not having access to drive is a barrier to many activities that promote independence. To address this barrier, Session Law 2017-41 directed the North Carolina Department of Health and Human Services, Division of Social Services to establish a two-year pilot project to assist youth in foster care in obtaining their learner's permits or driver's licenses.

In collaboration with county child welfare agencies, former foster youth, family partners, and other stakeholders, the Division created TRIP to serve as the pilot project designated by Session Law 2017-41. The purpose of TRIP is to provide, on a first-come, first-served basis, funding to support young people and caregivers with costs associated with obtaining a driver's license or learner's permit, including insurance, fees, and other costs.

Beginning January 1st, 2018 counties may submit reimbursement requests via email to <u>linksreimbursement@dhhs.nc.gov</u> for TRIP-eligible costs reimbursed to young people and caregivers by the county in the month of December. Funding for this two-year pilot program totals \$75,000 for each year (i.e. \$75,000 for SFY 2017-2018 and \$75,000 for SFY 2018-2019). Given the amount of funding appropriated, and the demand among young people, it is anticipated that these funds will be expended quickly. Reimbursement will be provided based on the availability of funds. Counties will be notified regularly of the status of funding so they may plan accordingly.
