In partnership with the Administrative Office of the Courts, the North Carolina Department of Administration, Commission of Indian Affairs Indian Child Welfare Committee is pleased to announce an upcoming event to educate and update child serving partners on Indian Child Welfare in North Carolina. Specifically, the objective of the Indian Child Welfare Education Symposium is to provide county agency staff training on the relevancy of culturally appropriate placement for children who enter the custody of county child welfare agencies and who are members of North Carolina state recognized tribes, as well as those who are protected under the federal Indian Child Welfare Act (ICWA).

The event will be held from 8am to 5pm on Friday, January 26, 2018, at Cape Fear Community College, located at 411 North Front Street Wilmington, NC 28429. Free parking is available on a first come-first serve basis. Continuing Education Units will be provided but must be applied for prior to the event. This workshop is open to county child welfare agency social workers and supervisors. Other invitees include judges, family law attorneys, attorneys representing county child welfare agencies, Guardian ad Litem staff, and tribal enrollment officers.

This year's event features Shanna Knight, MA, JD, a specialist on ICWA with the National Indian Child Welfare Association. She regularly provides training and guidance on the ICWA law, regulations, and guidelines to tribal and child welfare social workers, attorneys, and judges across the country. Ms. Knight will provide an interactive training for this Symposium covering the Indian Child Welfare Act, and the North Carolina General Statutes relating to American Indian children in North Carolina.
