## SUBJECT: MEMORANDUM OF UNDERSTANDING BETWEEN THE ADMINISTRATIVE OFFICE OF THE COURTS, DEPARTMENT OF HEALTH AND HUMAN SERVICES AND THE OFFICE OF INDIGENT DEFENSE SERVICES

The 2007 Federal Child and Family Services Review (CFSR) is a comprehensive Examination of each state's child welfare system. North Carolina's Case Review System was cited as an area needing improvement. As a result, the Administrative Office of the Courts, the Office of Indigent Defense Services (IDS) and the Department of Health and Human Services (North Carolina Division of Social Services) have entered into a Memorandum of Understanding (MOU) regarding the joint responsibility to protect and provide permanency to North Carolina's children while improving outcomes for families affected by abuse, neglect and dependency. A copy is attached for your review.

The state level MOU is designed to facilitate a collaborative relationship between parties involved in the Case Review System. It is our intention to improve the outcomes of safety, permanency and wellbeing of abused, neglected and dependent children who are in the court system. The MOU addresses best court practices, partner collaboration, training and local level implementation and is meant to provide a framework for working together. The MOU has been carefully developed by court and child welfare leaders who are committed to improving outcomes for children and families. We recognize that this endeavor requires time and attention at the state level as well as the local level.

We are encouraging each county to develop a local Memorandum of Agreement (MOA) or revisit existing MOA's by July 1, 2009. To help with this process, a local level Memorandum of Agreement (MOA) framework and a Procedural guide are attached. We are available for consultation in the development of your local level MOA. The local level MOA and Procedural Guide are being distributed to: 100 county departments of social services, the Court Improvement Project Advisory Committee, the Family Court Advisory Committee, Guardian Ad Litem staff and volunteers, parent attorneys (IDS) and judges. We encourage you to contact your county's chief district court judge and offer your assistance in convening a steering committee to begin the MOA development process.
