Re: Distribution of Funds from the Federal Adoption Incentive Program

You are the recipients of additional money from the Federal Adoption Incentive Program! We informed you on December 27, 2001 about your share of the federal incentive that we received for exceeding North Carolina's established baseline for adoptions during federal fiscal years beginning in 1998. At that time you shared in the amount of \$1,425,916 awarded to North Carolina. Our state's share should have been larger, but Congress had not set aside enough money to cover all the adoptions that were finalized by states. At the time of the awards, Congress indicated that additional funds would be appropriated. We are so pleased to inform you that North Carolina has been given an additional amount of \$1,300,321. Since this additional money should have been included in the first allocation, we are treating it as if it were and are giving it to those counties and private agencies who helped North Carolina exceed the baseline during that time period. This includes 91 counties and the four private agencies that have performance based contracts with the Division. The amount of the additional federal grants allows us to distribute \$619.49 per adoption that you finalized during fiscal years 98-99 and 99-00 as verified by the Adoption Information Management System (AIMS). The attached chart contains the amount of grant funds that your agency will receive.

The funds may be used for the promotion and support of adoption services. This would include recruitment, foster/adoption banquets, supplies, contracts, post-adoption services, and any other need that you may have that relates to the promotion of and provision of adoption services. The fund cannot be used to supplant other public funds; therefore, it cannot be used to re-finance existing services or activities. **The funds cannot be used for match for federal dollars.**

We have tried to simplify the process for the receipt of these funds and to get them to you as soon as possible. Therefore, we will not request reimbursement in the same way that was required for the previous grant. The only requirement is to complete the attached form which includes the description of the use of the fund and the cost of the purchase. We will review your request and if it shows that the funds will be used to enhance adoption, does not supplant existing services, and the figures are correct, your request will be approved. We will contact you if there are questions about your request. No other reporting is necessary. However, you must keep records for auditing purposes.

We will submit approved requests for payments to the controller's office at the end of each month. That office will make an electronic transfer to your agency. We anticipate that the transfer will be made within three weeks of the submission to that office. These funds must be expended by June 30, 2004. In order to assure that the funds are spent, you must submit your request by May 15, 2004. Funds not awarded to your county by that date will be made available to other counties.

We are very pleased that North Carolina has been awarded these additional funds and hope that you can make good use of this opportunity to improve adoption services. We are very proud of the outstanding work that you have done to provide permanency through adoption for so many children.
