DEAR COUNTY DIRECTOR OF SOCIAL SERVICES

SUBJECT: SFY 2004-2005 FACILITY RATES

ATTENTION: CHILD WELFARE SUPERVISORS CHILD PLACEMENT STAFF

The purpose of this letter is to provide you with information on the **Foster Care Maximization Program** and the list of **Facility Rates** for participating agencies for SFY 2004-2005.

This year's rate setting process included significant changes to the methodology used to establish the rates. In April of 2004, the Administration for Children and Families (ACF) communicated to DHHS of the need for these changes. To summarize, federal IV-E foster care reimbursement is set at a lower rate, and is fixed at 50%, for "administrative" costs incurred by Child Placing Agencies (CPA's) than is reimbursed for "maintenance" costs, which varies by FFY, currently 62.85%. The methodology used to set facility rates for Child Caring Institutions (CCI's) was not affected by this change.

Therefore, CPA's allowable costs for maintenance *only* and all allowable costs for CCI's will continue to be reimbursed via the automated system DSS-5094. Federal participation for all eligible costs entered in fields 50/51 will remain at the participation rate which is set at each federal fiscal year, currently 62.85%. The amount entered into field 50/51 will continue to be the amount the county paid for the costs of services, less any child resources used to pay for the cost of care. The amount used for the cost of care from the child's resources will continue to be indicated in field #56 on the DSS-5094.

In order to reimburse county DSS's and CPA's for administrative costs, the DHHS controller's office will calculate the reimbursements "manually". Costs incurred by county DSS's will be transferred via the NCAC EFT process. Private CPA's will be issued paper checks. The amounts will be based upon the number of eligible child caring days, as reflected on the DSS-5094, and the administrative rates, noted below.

The DHHS Controller's Office is responsible for establishing **Facility Rates** (i.e. cost-of-care rates) for agencies that participate in this program. In order to participate, agencies must comply with program requirements in North Carolina Administrative Code (10NCAC41M). The regulations in 10NCAC41M reflect federal regulations with which the DHHS Controller's Office, the Division of Social Services and agencies must comply in order for North Carolina to maintain this program. Private

child-caring agencies must enter into a formal contract with the Division in order to receive reimbursements directly from the state.

Establishing **Facility Rates** allows North Carolina to claim additional federal IV-E and TEA foster care reimbursements for county DSS agencies and participating private child-caring agencies. Specifically, this program enables the state to receive federal IV-E and TEA reimbursement for costs in excess of the standard board rate that are incurred on behalf of IV-E and certain TEA eligible children.

If the cost of a child's placement is in excess of the standard board rate, it is very important that county DSS staff ensure that the child-caring agency is participating in the maximization program. If a county DSS determines that a potential placement resource for an eligible child does not have a Facility Rate established by the DHHS Controller's Office, the county DSS who places the minor will be responsible for the portion of the cost of care in excess of the standard board rate. The facility or agency may contact Kevin Kelley at (919) 733-4570 to request inclusion in the Maximization Program to determine if they meet the requirements.

For child-caring facilities operated by county Departments of Social Services, federal IV-E and TEA maximization reimbursements are received directly by the county Department of Social Services. In such situations, the established monthly **Facility Rate** must be shown in Field 50 (Monthly Rate) of the DSS 5094 in order for the county DSS to receive the full maximization reimbursement.

According to federal and state regulations, foster care payment claims are not allowed to exceed the state-established Facility Rates. Therefore, if counties choose to pay an amount greater than the state-established Facility Rate, no reimbursement is received for the amount in excess of the Facility Rate. In addition, North Carolina Administrative Code includes a cost containment requirement in which the Child and Family Services Association of North Carolina recommends a cap or maximum facility rate for each type of care each year. Therefore, no Facility Rate established by the Division is allowed to exceed the maximum rate established, regardless of the facility's actual cost of care.

The caps (maximum allowable, monthly cost of care) set for each type of care for FY 2002-03 are as follows:

Family Foster Care; Administration = 1859 Maintenance = 2091 Group Care = 5887 Institutional = 5711 Emergency = 6261 Therapuetic Camping = 3780

Agencies who qualify for IV-E maximization in one type of care, and begin offering an additional type of care during the SFY, will be authorized for the state average for that new type of care.

The state averages for each type of care for the 2004-2005 SFY are:

Family Foster Care; Administration = 1200 Maintenance = 890 Group Care = 4863 Institutional = 4704 Emergency = 5204 Therapuetic Camping = 3780 The enclosed list indicates with an asterisk (*) those agencies that are also members of the State Funds Program. State Funds are designated to supplement the foster care costs for <u>non-IV-E</u> <u>children</u> in placement with member agencies. Reimbursements are made based on the available funds and the agency's Facility Rate less any foster care payment and child's resources shown on a child's DSS 5094. Counties that pay in excess of the Standard Board Rate for children placed with these agencies should be able to realize some reduction in county costs for these placements.
