### SUBJECT: Work First Training: CORNERSTONE IIIB

In anticipation of our suggested training needs and as part of our ongoing training efforts, the Division is pleased to announce a very special training opportunity for the Work First Program Staff.

Cornerstone IIIB is a foundational training on the principles, knowledge, and skills related to family-centered practice. This 3-day workshop provides foundation training in family-centered practice for Work First workers and their supervisors. The workshop will be based on the six principles necessary for family-centered partnership. Day one begins with an opportunity for participants to use two solution-focused tools to assess and set goals for the practice. Day two provides an in-depth look at each of the six principles of partnership and Day three provides an opportunity for each participant to make the principles their own as they use their "toolbox" with an actual case. This training was developed by Appalachian Family Innovations, Appalachian State University.
