SUBJECT: Required Training Prior to Conducting Family Assessments

There have been many questions lately regarding training requirements for employees and collaborative students who will be conducting Family Assessments. This letter is an attempt to clarify current expectations.

As you know, MRS Policy Training and Cornerstone III have been required trainings for employees before they are considered eligible to receive Family Assessment cases. However, the Division is currently incorporating MRS Policy and Family-Centered Practice information from Cornerstone III into pre-service and the job specific courses. Therefore, any employee who attended pre-service which **began** on or after Oct. 17, 2006, has met the training requirements and can conduct Family Assessments or Investigative Assessments once they have completed pre-service. These employees will still be required to attend their job specific training (*Investigative and Family Assessments in Child Welfare Services*) within their first year of employment.

MRS Policy and Cornerstone III have not yet been incorporated into the curriculum for current collaborative students. Until that process is completed, collaborative graduates and interns will need additional training before Family Assessment cases can be assigned to them. There are two options for these students, and for any employee who had preservice which began prior to Oct. 17, 2006 and who has not yet attended MRS Policy Training and/or Cornerstone III. Students and employees can take the course *Investigative and Family Assessments in Child Welfare Services* which will be offered in the Winter/Spring 2007, or they can access the *Self-Study Guide for Family Assessment* which can be found on the Division s website under MRS Documents. The Self-Study Guide is designed to be used under the guidance of a child welfare supervisor or a county child welfare trainer. Either option will meet the requirement for MRS Policy Training and Cornerstone III prior to receiving Family Assessment cases. Some collaborative students will have already completed the Self-Study Guide prior to placement in your agency.

We hope this clarification will be helpful to you as you plan assignments for your new employees and collaborative students and will give you options for their growth and development.
