#### SUBJECT: FNS ERROR RATE REDUCTION TRAINING

#### DATE: JANUARY 7, 2015

The Operational Support Team (OST) has developed training for staff with responsibilities related to the administration of the Food and Nutrition Services Program. The emphasis of this training is to help reduce the Quality Control Error Rate for North Carolina as well as give workers helpful strategies that will save time in their daily case maintenance duties.

We have scheduled eight (8) sessions across the state. Each training site will have a 9:00 a.m. and 2:00 p.m. session. We anticipate that each training session will last approximately 2.5 hours. There will be a limited number of seats available so we ask that each county send a maximum of five (5) individuals. Attached to this letter you will find information identifying the training session your county can attend.

Topics that will be addressed include income, deductions, verifications, notices, trial budgets, and NC Fast Navigation.
