Re: Food and Nutrition Services (FNS) Management Evaluation (ME) Tentative Schedule and Summary of Findings

Dear County Director of Social Services:

Attention: Food and Nutrition Services Managers and Supervisors

Food and Nutrition Services Program regulations subsequent to the Food and Nutrition Act of 2008 require the state to conduct Management Evaluation Reviews in each county. The frequency of the review is based on the FNS caseload size. A tentative schedule for Federal Fiscal Year 2013-14 is attached for your information. This schedule is subject to change. An official notification will be sent to Directors and FNS Managers at least thirty (30) days prior to the scheduled evaluation with instructions.

The objectives of the review are to provide:

- A systematic method of monitoring and assessing program operations; and
- A basis for counties to improve and strengthen program operations by identifying and correcting deficiencies; and
- A continuous flow of information between county, state and federal partners in order to develop solutions to problems in program policy and procedures.

In order to accomplish the objectives, the review will include the following nationwide priority areas:

- Timely processing of applications and recertifications
- Payment Accuracy
- Civil Rights
- Program Access to include hours of operation, limited English proficiency
- Program Integrity to include social media monitoring, hearing processes and FNS EBT trafficking
- Timeliness of State Hearings and Appeals
- Crisis Intervention (CIP) and Low Income Energy Assistance Program (LIEAP)

Regulatory Provisions/ FNS Guidance/Policy	Findings
305.04; 315.02	The county agencies did not meet the timeframes for processing applications/reapplications.
310.01 – 310.04	The county agencies failed to conduct an interview for all applications received prior to the issuance of FNS benefits.
320.03	The county agencies failed to provide households entitled to expedited service with FNS benefits no later than the seventh calendar day following the date an application was filed.
425.01	The county agencies did not complete applications for recertification prior to expiration of certification periods.
635	The county agencies failed to issue proper notification of denials on adverse actions.
120.0 – 120.02	The county agencies failed to conduct and maintain a log of annual Civil Rights Orientation and Training conducted for new staff and current staff.
825.04 & 710.06	The county agencies failed to impose the intentional program disqualification effective the month following the month the client is notified of a disqualification due to signing the DSS-8588, Waiver of Administrative Disqualification Hearing.
