RE: Systematic Alien Verification for Entitlements Program (SAVE) Monitoring and Deactivation of Unused Accounts

ATTENTION: County Security Officers, Food and Nutrition Services Administrators

Dear County Director of Social Services:

The SAVE Program provides a fast, secure and efficient verification service for federal, state and local benefit-granting agencies to verify a benefit applicant's immigration status or naturalized/derived citizenship. SAVE is administered by the U.S. Citizenship and Immigration Services, a component of the Department of Homeland Security, and provides program support and customer service to participating agencies.

Effective August 1, 2016, SAVE implemented new rules regarding the use of their system. SAVE users, including Super Users, supervisors and general users who have not accessed the system within a 270-day period, will be deactivated. Security officers/supervisors must review the status of all users assigned to their agency to determine if SAVE access is still required for any of their users. Access must be terminated immediately for anyone that no longer needs access to SAVE.

SAVE has identified over 1,000 users in North Carolina that have not accessed the system for at least 270 days. A report identifying these users is attached to this letter, this report is sorted by county. Security officers/supervisors must review the report and determine if access to the system is still needed. If access is needed, users must log into SAVE immediately for their accounts to remain active.

The SAVE Program now provides a Self-Assessment Guide to help agencies perform internal monitoring and compliance assessments. The Guide offers easy to follow checklists based on SAVE requirements to assist you in developing your Agency's compliance program, the guide is attached to this letter.
