Subject: Benefits Data Trust (BDT) Text Messages

Priority: Information Only

North Carolina Department of Health and Human Services (DHHS), was selected in 2016 to partner with Benefits Data Trust (BDT) through a national funding opportunity to increase participation in the Food and Nutrition Services Program (FNS) for seniors dually enrolled in Medicare and Medicaid. BDT is a national nonprofit organization that provides comprehensive application assistance to help low income individuals and families gain access to needed services and benefits. BDT uses invested time and resources in analyzing data to focus on the outreach and enrollment assistance that involves outreach mailings and telephonic signature for households who are not enrolled in Food and Nutrition Services.

As part of a new outreach project, BDT will be sending text messages along with outreach letters to low income individuals and families 18 years of age and over receiving Medicare and or Medicaid who may be eligible for Food and Nutrition Services. The text messages will provide information regarding how to apply for Food and Nutrition Services benefits and direct them to call the North Carolina Benefits Center at 1-855-486-9333 Monday-Friday 9am-5pm. The North Carolina Benefits center provides assistance with questions and concerns regarding the Food and Nutrition Services application and enrollment process. The NC Benefits Center will complete the application via ePASS with the applicant over the telephone. For SNAP applicants, the application will be completed by telephone and faxed to the local DSS office.

The text messages will never ask for personal information or contain shortened links that look suspicious (links that do not display the entire web address). Households will have the opportunity to opt out of the text messages at any time.

Below are some examples of the text messages that BDT will begin sending out January 1, 2021:
