Subject: Use of MA, WF and SA Functionality for Project 2&6 Pilot Counties Only on 8/5/13

Dear County Director of Social Services:

On Monday, August 5, 2013, NC FAST will implement new system functionality supporting case management for the Medicaid (MA), Work First (WF) and Special Assistance (SA) programs. (Functionality supporting the Refugee Assistance program will be implemented at the conclusion of statewide Soft Launch at the end of September 2013.) This marks a significant milestone for NC FAST and invokes new, complex system functionality supporting eligibility determination for these programs.

To focus our support resources and minimize the risk of disruption to client benefits in non-pilot counties, we strongly request that non-pilot counties do not attempt entry of any applications for these programs until formally notified by the NC FAST team. In the meantime, applications received for the FNS and SNAP programs can continue to be processed in NC FAST as normal.

Starting August 5, the NC FAST team will be running a daily system query to identify any non-pilot county entering applications in NC FAST for any programs besides FNS and SNAP. We will notify NC DHHS leadership if we identify any non-pilot county entering applications for MA, WF and SA prior to being directed to do so by the NC FAST team. We will also follow up with the director of any non-pilot county identified by this query.

The intent is to confirm that the system is correctly processing benefits for the MA, WF and SA programs before widespread use of this functionality. Please ensure the staff in your county are aware of this guidance. We expect to allow Phase 1 counties to begin using Project 2&6 functionality on Monday, August 12, and the Soft Launch dates for the remaining phases have not been affected. The following figure shows the Soft Launch milestones for each county for Project 2&6.
