## DEAR COUNTY DIRECTOR OF SOCIAL SERVICES

## **SUBJECT:** Shared Information between Economic Services and Child Support Enforcement in the Client Services Data Warehouse (CSDW)

The Client Services Data Warehouse (CSDW) has been available to your organization for several years. One of the goals of the CSDW is to provide agency-wide information where possible thus allowing the sharing of information across local agency business areas. So far, information in the CSDW supports the Services Information System (SIS), Central Registry, the Eligibility Information System (EIS), the Food Stamp Information System (FSIS), and Subsidized Child Care information sharing. Child Support data from the Automated Collection and Tracking System (ACTS) has been added to the list of data that is shared via the CSDW.

This shared information is available to you in a new universe: DSSCSMGT (DSS Case Management). Your designated Security Officer must place a request with the DHHS Customer Service Center (CSC) for your staff to get access to this new universe. Several state sanctioned queries have been created using this new universe. These queries, which are listed below, are published in Corporate Documents for your use in the State Sanctioned DSS and Child Support Queries category. The query, "DSS Individual Search by SSN", allows you to find individuals across several business areas and systems (EIS – Work First, Special Assistance (SA), and Medicaid; SIS – Services; FSIS – Food Stamps; and now ACTS - Child Support Enforcement). By entering a single Social Security Number you can identify the benefits and/or services an individual is receiving via your county department of social services.

**Editing Reports:** Reports published in CSDW have 2 types of icons. These icons indicate which tool was used to create them and whether these reports may be edited.

- These reports may be edited via the CSDW Web Tool
- These reports may NOT be edited via the CSDW Web Tool.

**Technical Notes to Share with Staff:** To keep all data in one place, we had to make use of a special feature in the tool we use to publish the data. This feature allows us to create two identical copies of the ACTS Participant table to link it to others either by Social Security Number or by Individual ID. They are called ACTS Participant (joins w/ Ind ID) and ACTS Participant (joins w/ SSN). If a query is written using fields from both ACTS Participant tables the following error message is received: "Incompatible Combination of Objects". To prevent this, choose which table to use in a query and do not use fields from the other table. The ACTS Participant table is the only table affected by this.

**Linking Tables by Social Security Number or by Individual ID** – Data between EIS and Child Support can be linked either by Individual ID or by Social Security Number. When users create new reports using EIS and CSE data, they must use either the ACTS Participant SSN or

ACTS Participant Individual ID table to link the data. If users fail to use one of these Participant tables, the following window will offer a choice:



Once the choice is made, the query will execute accordingly.
