RE: FSIS Lite Bi-Annual Security Reviews

## **County Directors of Social Services**

## **ATTN: County Security Officers**

Due to the decommission of the Food Stamp Information System (FSIS) in May 2013, the Historical Data Inquiry System (referred to as "FSIS Lite") was created to view historical data and conduct investigations utilizing inquiry only access. The system also archives historical data collected in FSIS.

A new security report has been created for FSIS Lite. Counties must review this report twice per year to ensure appropriate User access is maintained. These reviews must be documented on Appendix 13 available in the DSS Security Manual. The completed Appendix 13 should be maintained in the county DSS records. The Food Stamp Information System (FSIS) Security Report has been removed from the list of required reports to be reviewed. The following is a complete list of semi-annual security reviews that must be performed and documented on Appendix 13:
