SUBJECT: Interpreter Services for the Deaf, Deaf-Blind and Hard of Hearing

The North Carolina Division of Social Services recognizes that local Departments of Social Services have a need for interpreting services to support those individuals and families who may experience Deafness, Deafness-Blindness, and/or Hard of Hearing. Providing sign language interpreter services ensures equal access and effective communication to those families.

To ensure quality interpreting and transliterating services for all Deaf, Deaf-Blind and Hard of Hearing people in North Carolina, a North Carolina Interpreter and Transliterator Licensure Act (N.C.G.S 90D) was created. The Division of Services for the Deaf and the Hard of Hearing (DSDHH), of the North Carolina Department of Health and Human Services (DHHS) is required by General Statue 8B, to "prepare and maintain an up-to-date list of qualified and available interpreters." The directory links below is a direct result of that legislation. Included in the following directory you will find listings of interpreters who are Licensed and hold one or more of the current credentials: Registry of Interpreters for the Deaf (RID) Certifications; National Association of the Deaf (NAD) Certifications; and North Carolina Interpreter Classification System, level A, B or C. This directory is for your convenience in locating a licensed interpreter.
