

Counties successfully met the Feb. 10 and March 31 USDA FNS processing deadlines.



Counties successfully met Feb. 10 and March 31 USDA FNS processing deadlines.



### **Overall Medicaid Applications Processed**


- 95% of new applications were processed in NC FAST to date in November, with 5% processed in EIS.


### **Special Assistance Applications Processed**


### **Refugee Assistance Applications Processed**

### HealthCare.gov Applications by Status

- 8,544 applications from 2014-2015 Open Enrollment submitted at healthcare.gov have been transferred to NC FAST.
- 23% of those applications have been fully processed by the state.
- 8% of the fully processed applications were approved for Medicaid; the remainder were denied, withdrawn, or transferred.



### **Pending Medicaid Applications**

- There are currently 14,202 pending Medicaid applications in NC FAST and EIS that are beyond standard processing time (*Compared to 2014 peak of 104,070*):
  - FFM Applications: 720 (Compared to 2014 peak of 45,058)
  - NC FAST MAGI Applications: 3,381 (Compared to 2014 peak of 31,890)
  - NC FAST Traditional Applications: 9,343 (Compared to 2014 peak of 20,938)
  - EIS: 758 Compared to 2014 peak of 9,051)






## **Total Untimely Pending Medicaid Applications**

- We continue to monitor statewide and individual county progress in working through untimely pending Medicaid applications.
- Since the peak of untimely pending applications at the beginning of June, counties have been successful in lowering the overall backlog by 89% which includes a reduction of approximately 92,000 untimely pending applications.



 29% of the untimely pending Medicaid applications are directly related to Affordable Care Act changes.






# Breakdown of Untimely Pending Apps

- There are 720 untimely pending Medicaid applications from the FFM.
- There are 3,381 untimely pending Medicaid applications for MAGI Programs received online or in county DSS offices.






\*Note: For the week ending Sept. 3, an adjustment was made to the reporting for NC-Based MAGI pending applications. Previously, reports used the received date to calculate timeliness. The adjusted reports now use the application date. As a result, there was an increase in the number of NC-Based MAGI applications being counted as untimely this week.




# Breakdown of Untimely Pending Apps

- There are 758 untimely pending Medicaid applications in EIS for Traditional Programs.
- There are 9,343 untimely pending Medicaid applications in NC FAST for Traditional Programs.



\*Note: Pilot county pending cases that were converted from EIS to NC FAST in December were erroneously being counted as untimely and unprocessed through the week of May 26<sup>th</sup>. This is the primary source of the significant drop in EIS untimely applications between the May 28 and June 4 counts.



### **Medicaid Recertifications Processed**

- Historically, the average number of recertifications processed each month in EIS is 82,191. The average overdue recertifications per month is 7,166, and the average extended per month is 6,578.
- December through April totals are increased due to the Medicaid Waiver extensions.



### **Pending Medicaid Recertifications**


A total of 262,122 Medicaid recertifications are pending through the end of the calendar year.




### Rate of Help Desk Tickets

### **Medicaid Streamlined Processing**

In an effort to reduce the number of Medicaid cases currently overdue for recertification, DMA is evaluating a number of options to assist counties in completing these recertifications in a less time intensive manner. Once these options have been thoroughly evaluated, DMA will issue further communication explaining what changes, if any, will be made to current policy or procedural guidance. Some of the items being considered:

- Relax NC FAST system requirement for supervisor to approve changes to citizenship and citizenship verification items. (Implemented 11/8/2014)
- Relax NC FAST system requirement for supervisors to have to approve cases processed using forced eligibility for P7 Retro, P7 Emergency, P7 Transitional, 2101f, and MIC-L.
- Relax requirement calling for two verifications of residency in order to process Medicaid (This will required legislative changes for 2015 Legislative Session)
- Combine DMA forms 5067 and 5199 required to notify client of upcoming review and gather tax filing information into one form and send en masse to all clients with reviews coming due in the next three months.



## **County Streamlined Processing**

- Identify and bring on additional temporary staff and/or vendor staff to assist with case processing
- Dedicate specific individuals to handle applications received via Healthcare.gov
- Dedicate individuals to track distribution and receipt of forms. Institute a follow up procedure to encourage clients to return information before the 30 day window expires
- Facilitate county "moonlighting" to allow counties that are caught up to assist impacted counties with case processing
