



County DSS Director's Update June 2, 2015



General NC FAST Update

- NC FAST received notification from CMS that a defect has been preventing the
 account transfer of approximately 9,100 accounts where a full state determination
 for Medicaid eligibility when applying via the FFM was requested. Subsequently,
 North Carolina began receiving these account transfers on May 27th and the
 corresponding applications are now being sent to the applicable county work
 queues. If received, these applications should be processed per normal
 procedures.
- Please note:
 - NC FAST will apply stop processing times to FFM apps with more than five days in between FFM app date, and NC FAST received date. Workers will not need to add a stop processing record.
 - Dates for these applications will be excluded for report card.
- Certification periods of Family and Children's Medicaid cases subject to MAGI rules will be automatically extended on June 17th for the counties where automatic certification period extensions are still needed.



General NC FAST Update

- A communication regarding outstanding SDX exception tasks that need to be processed in order for clients to receive benefits was issued on May 14th, 2015. A report of the open SDX exceptions was made available on FAST Help. As of Friday, May 29th, approximately 300 of the SDX exceptions on that report remain unresolved. Please ensure that your staff resolve these exceptions as soon as possible as well as continually monitor the SDX exception work queue for future exceptions.
- A County Champion Call and Webinar on SDX case processing was held on May 19th. A recording of the webinar along with the slides and the questions and answers were distributed via the NC FAST Weekly communication.
- A Dear County Director Letter regarding providing auditors access to NC FAST has been released. Please reference this letter for official guidance on providing auditors with access to requested information or systems.
