# NC FAST-CSDW-Day Sheet Interface Pilot

#### **Overview**

#### Plan B

- Temporary solution to recording time spent working in NC FAST
- ▶ Workers code time to 890, 891 or 892 with specific Program Codes
  - Use Program Code(s) based on primary "focus" of action
- Issue with Plan B
  - Workers know what they are doing and how long it takes them
  - Workers do not necessarily know which or how many Product Delivery Cases are impacted by their actions
  - Creates issues for accurate coding of time to specific fund sources (SIS Program Codes)

#### Plan A

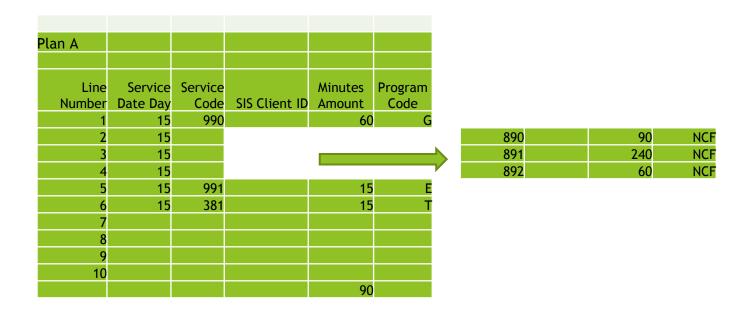
- Capture impact of worker actions in NC FAST on Product Delivery Cases
- Utilize data from NC FAST to allocate recorded time across applicable programs
  - Concept similar to Random Moment Sampling
- Reduce day sheet coding burden on county staff using NC FAST

Workers code their time actively using NC FAST to the same Service Codes as used in Plan B, but with a "generic" Program Code, "NCF"

#### What will change and Expected Impacts

- ▶ The Interface impacts only time coded to 890, 891 or 892
- All workers using NC FAST should code 890, 891 and 892 time to NCF on their day sheets
- If your county FTPs your day sheet data it will be VITAL that you submit your file successfully and before the cut off
- > You will likely see some changes in the allocation of costs for worker time
- The Interface will be allocating Work First Employment Services activity to TANF (Program Code R) rather than MOE (Program Code 9)
  - New Application Codes/DSS-1571 Part I coding will allow county Finance Offices to move costs from one fund source to the other
  - ▶ Work First Cash Assistance activity will continue to allocated to MOE
- Counties will not apply a Penetration Rate for 890, 891 and 892 coded to Program Code "HC" in NC CoReLs - the Interface will determine the correct percentages of MA vs HC by activity
