Determine your adoption rate by dividing the number of completed adoptions in one year by the number of youth in care the year prior.

Determine which adoption rate is lowest – the Year 3 adoption rate or the average of the past 3 years. Multiply the lowest adoption rate by the number of youth in care in Year 3 to determine your baseline for the current year.

Funding for SFY 2018-2019

Private Agencies:

Total budgets for SFY 2018-2019 contracts will be based on final 2017-2018 contract amounts. The total contract amount will be a combination of direct pay value (thru December 31, 2018) and the remaining contract budget. The effective date of the contracts will be January 1, 2019. For pending adoptions not finalized as of December 31, 2018, private child placing agencies will coordinate with child welfare agencies to transition to the Revised DSS-5113 Adoption Services Agreement to reflect the new service areas.

County Agencies

To secure the use of funds that are set-aside for SFY 2018-2019, adjustments are being made to ensure payments can occur within the fiscal year timeframes. This means for SFY 2018-2019, counties will submit adoptions completed beginning July 1, 2018 – May 31, 2019. Beginning in SFY 2019-2020, agencies will submit adoptions for June 1, 2019 – May 31, 2020.

For SFY 2018-2019 county agencies will submit adoptions completed July 1, 2018 – November 30, 2018 by December 10th, followed by submissions on March 10th, and no later than June 3rd.

For pending adoptions not finalized as of December 31, 2018, that include private agency partnership, county child welfare agencies will coordinate with private child placing agencies to transition to the Revised DSS-5113 Adoption Services Agreement to reflect the new service areas.
