









Tables highlight the percentage of children with a finding of Substantiated or Services Needed with a Primary Contributory Factor recorded in 2007-2008. Contributory Factors are separated into categories depending on whether the factor is specific to the child, caregiver or household. **Note that 73.7% of assessments with findings of Substantiated or Services Needed were NOT assigned any Primary Contributory Factors.** Therefore, the data above may not be representative of the entire population. Repeat Assessment is defined as a child who received a finding of Substantiated or Services Needed with an identified Contributory Factor during fiscal year 2007-2008 and who was involved in another accepted report within 6 months of the substantiated report. The % reflects percentage of children with a given Contributory Factor who had a Repeat Assessment.

Status of Data Collection and Reporting

- A total of 1526 assessments were reported to the Central Registry.
- Of these, 1389 assessments (91.0%) were reported through the web-based Multiple Response Database.
- So, 137 assessments (9.0%) reported to the Central Registry were NOT registered in the Multiple Response Database.
- Of the 1389 assessments reported to both the Central Registry and the Multiple Response Database, 53.3% included some information about MRS services that were needed, referred or provided.
- For the assessments with some MRS services information, **29.1%** of the reported services were referred and/or provided with no indication of the service being needed.

MRS Services Needed, Referred, and Provided

Of the assessments with reported services, the top 5 identified service needs in the select county accounted for 60.2% of all identified service needs.
