







Tables highlight the percentage of children with a finding of Substantiated or Services Needed with a Primary Contributory Factor recorded in 2007-2008. Contributory Factors are separated into categories depending on whether the factor is specific to the child, caregiver or household. Note that 63.8% of assessments with findings of Substantiated or Services Needed were NOT assigned any Primary Contributory Factors. Therefore, the data above may not be representative of the entire population. Repeat Assessment is defined as a child who received a finding of Substantiated or Services Needed with an identified Contributory Factor during fiscal year 2007-2008 and who was involved in another accepted report within 6 months of the substantiated report. The % reflects percentage of children with a given Contributory Factor who had a Repeat Assessment.

Status of Data Collection and Reporting

- A total of **650** assessments were reported to the Central Registry.
- Of these, **592** assessments **(91.1%)** were reported through the web-based Multiple Response Database.
- So, 58 assessments (8.9%) reported to the Central Registry were NOT registered in the Multiple Response Database.
- Of the 592 assessments reported to both the Central Registry and the Multiple Response Database, 29.1% included some information about MRS services that were needed, referred or provided.
- For the assessments with some MRS services information, 33.4% of the reported services were referred and/or provided with no indication of the service being needed.
