The intent of this bulletin is to provide information/guidance to LME MCOs regarding Research-Based- Behavioral Health Treatments (RB-BHT) for Autism Spectrum Disorder (ASD).

The Centers for Medicare and Medicaid Services (CMS) have approved North Carolina's State Plan Amendment (SPA) for RB-BHT. Attached to this bulletin is the approved SPA which will serve as the definition until the new policy has been promulgated. LME MCOs are to use this definition for the purposes of authorization, monitoring, and reimbursement.
