Subject: LME-MCO Certification Data Validation Process

Over the past few months, the Division of Health Benefits (DHB) has been working with GDIT to create a report that identifies the encounter files submitted to NCTracks. The report reflects the Certification data that you submitted to DHB since July 1, 2019.

In the future we want to use these files as part of the Certification process. Over the next 60 days we need you to review and monitor report number IR20706-R2706, to determine if we are properly capturing your encounter files on a weekly basis. We will organize a conference call within the 60-day period to discuss any questions you may have about the report.

Once we receive confirmation from all seven plans, we will begin using this report to validate the Monthly Certification data that your agency sends to DHB. Please do not change the reports that you currently send to DHB. Our expectation is that the Encounter data submitted via NCTracks should match the encounter certification reports submitted by the MCOs.
