## 11:00AM-12:00PM

Each Member and the two guest speakers from Alliance Behavioral Healthcare provided a brief introduction of their history in mental health, current service/employment and roles in the State of North Carolina, successful programs and areas of concern. Several areas of focus were identified including: foster care, primary care coordination, outpatient mental health services, Juvenile Justice, need for evidence-based frameworks and systems, and use of psychotropic medications in children and adolescents.

#### 12:00-12:20PM

Eric Johnson and Stephanie Pollard provided background and the history of Alliance Behavioral Healthcare, which is Managed Care Organization (MCO) for Wake, Johnson, Durham and Cumberland Counties. Eric Johnson detailed the services performed by Alliance Behavioral Healthcare and their network providers. Care of individuals with Intellectual Disabilities and Intensive In-home services were identified as the first and second highest service expenditures for Alliance Behavioral Healthcare.

#### 12:20-1:20PM

Members asked questions of the guests from Alliance Behavioral Healthcare. Successful evidence-based programs were identified and discussed such as Multisystemic Therapy (MST) and Functional Family Therapy (FFT). The components of successful programs currently operating were identified. Utilizing Mental Health First Aid, a community-based educational program, for addressing issues of stigma and assisting communities with assessment and intervention for individuals experiencing mental health issues. Mr. Johnson stated monitoring of intensive in-home services and care coordination with primary care are areas for improvement. Relating to intensive in-home therapy, the need for evidence-based framework and auditing of services was verbalized by the committee. The need for further assessment of current services and gaps in services of special populations were identified including: children and adolescents in foster care, in the Juvenile Justice System and care coordination in primary care. Committee members selected to work in small groups and obtain statistical data, list of current services, and address the duties of the workgroup.

1. Examine the efforts that heighten awareness and reduce stigma related to substance use and mental health problems, and provide recommendations to improve these efforts.
