She gave a brief description of the fact sheets in the development process from the Customer Service and Community Rights Team, and that State CFAC had made recommendations for more inclusive language that was less stigmatizing to the person being evaluated. Benita referenced the Prevalence and Penetration presentation and how this data helps CFACs understand service gaps and needs, as well as who is accessing services.
