1.0 INTRODUCTION

Through this Request for Applications (RFA), the NC Department of Health and Human Services; North Carolina Division of Mental Health, Developmental Disabilities and Substance Abuse Services (DMHDDSAS) is launching the NC Strategic Prevention Framework - Partnership for Success (SPF-PFS) grant funded by the Substance Abuse and Mental Health Services Administration (SAMHSA), Center for Substance Abuse Prevention (CSAP). Through this initiative, the Department seeks to collaborate to use the Strategic Prevention Framework to address target substances of abuse with Local Management Entity-Managed Care Organizations (LME-MCOs), Community-based organizations implementing substance abuse prevention, and Community coalitions working to address substance abuse prevention.

1.1 PURPOSE

This project will be utilized to address specific prevention priorities within our state. Areas of focus include: Alcohol use among persons aged 9 to 20, Electronic Vapor Product use (i.e. e-cigarettes, vaping pens, etc.) for individuals age 9 and above, and Marijuana use for individuals age 9 and above.

As described in the background section, NC DHHS is sponsoring this RFA to address substances of high use and impact using evidence-based prevention policies, programs, and practices. Funded applications must utilize the Strategic Prevention Framework to plan and implement this initiative. Alcohol use among youth and young adults must be addressed in each funded proposal, in combination with either electronic vapor products, or marijuana use. Proposals can elect to also address either electronic vapor products or marijuana based on community level data or a compelling case for why this is a priority.

1.2 BACKGROUND

NC DHHS is committed to proactively planning for and addressing substances of concern in communities. This includes legal substances of use for adults that are being utilized by young people and substances that are on the rise in adolescent use.

In North Carolina, 26.5% of youth report current alcohol use and 12.4% of those who use alcohol reported binge drinking (4 or more drinks for females / 5 or more drinks for males) in the past 30 days. (NC YRBS 2017) 39.9% of youth surveyed reported that their alcohol was given to them. (NC YRBS 2017) The remainder of students reported some combination of: purchasing it at a store, restaurant, public event; giving money to someone else to purchase; taking it without permission from home, a friend or another relative's home or a store. 15.6% of high school students reported that they had their first drink of alcohol before age 13. (NC YRBS 2017) 8.9 % of middle school students reported having their first drink of alcohol before age 11. (NC YRBS 2017)

Statewide, 44.1% of high school students (51.2% of 12th graders) reported having used an electronic vapor product (NC YRBS 2017). 22.1% of high school students report current use (past 30 days) (NC YRBS 2017). Significantly, there is an 894% increase in e-cigarette use among high school students in NC since 2011. (2017 NC Youth Tobacco Survey). Among the 8.7% of students nationwide who reported current use of electronic vapor products who were aged less than 18 years of age, 13.6% had usually acquired their own electronic vapor products by buying them in a store (e.g., convenience store, supermarket, discount store, gas station, or vape store). The prevalence of attaining their own electronic vapor products by buying them in a store was higher among 12th-grade (22.9%) than 9th-grade (8.7%), 10th-grade (11.6%), and 11th-grade (14.3%) students. Among middle school students, 12% of 6th graders reported having used electronic vapor products. 16.4% of 7th grade students and 28.3% of 8th Rev. 03.15.16

grade students reported having used an electronic vapor product (NC YRBS 2017).

Nationwide, 35.6% of high school age youth had used marijuana one or more times in their life and 19.8% of students had used one or more times during the past 30 days. (i.e., current marijuana use) (YRBS 2017). Nationally, recent trends in risk and disapproval rates indicate that youth perception of risk/harm has decreased steadily as has their disapproval of use. (Monitoring the Future 2018) 6.5% of high school students reported that they tried marijuana for the first time before age 13 (NC YRBS 2017). 4.1% of middle school students reported trying marijuana for the first time before age 11 (NC YRBS 2017).

This round of SPF-PFS funding will address underage drinking in North Carolina (REQUIRED). In addition, communities may choose, but are not required, to focus on one additional area: prevention of either electronic vapor (e-cigarette) product(s) or marijuana use for individuals 9 and above.

2.0 **ELIGIBILITY**

The North Carolina SPF-PFS will be primarily focused on preventing alcohol use of individuals aged 9 to 20 through strategic planning and implementation of environmental management strategies (Optional: Electronic Vapor (e-cigarette) Products or Marijuana for individuals 9 and above).

Eligibility requirements include:

- Applicant must have a demonstrated presence and operations in North Carolina for a minimum of 1 year prior to proposal submission.
- Applicants must have affiliation with a host organization (e.g., an organization with 501(c)(3) or NC non-profit status) and be able to receive federal funds.
- Applicant may not be funded through Drug Free Communities (DFC) or Partnership for Success (PFS) after September 30, 2019.
- 2) Applications MUST include a focus on underage (ages 9 through 20) alcohol use.
 - Applicants may also choose (OPTIONAL) to include one additional area of focus including electronic vapor (e-cigarette) product use or marijuana use (ages 9 and above), depending on local needs and demonstrated readiness to address the issue.
- 3) All eligible applicants are invited to apply; however, **priority consideration will be given to**:
 - Those who have never received Drug Free Community (DFC) or Partnership for Success (PFS) funds
 - Applicants whose service areas are in one or more of these 20 counties: Wilson, Currituck, Avery, Catawba, Hertford, McDowell, Union, Lincoln, Nash, Haywood, Wake, Lee, Carteret, Jackson, Sampson, Ashe, Swain, Forsyth, Cumberland or Moore
 - Initiatives focused on or in collaboration with one of the following:
 - Military Communities
 - Historically Black Colleges or Universities (HBCUs)

- 4) The applicant **must** agree to **measure and report** outcomes, established and approved by PFS Evaluators and the Division of Mental Health, Developmental Disabilities and Substance Abuse Services (DMHDDSAS). Applicants must demonstrate the ability to comply with the PFS National Cross Site evaluation requirements.
- 5) Refusal of Funds from Alcohol, Tobacco, Electronic Vapor Product and/or Marijuana Entities The applicant and/or its affiliate(s) agree that it shall not accept any grant or anything else of value from any alcohol, tobacco, electronic vapor product and/or marijuana manufacturer, distributor, or other alcohol, tobacco, electronic vapor product or marijuana related entity.
- 6) No Harm reduction initiatives- The applicant agrees that strategies should be aimed at efforts to prevent alcohol and e-cigarette and/or marijuana use and should not focus efforts to reduce the negative consequences associated with such use (e.g. promoting a campaign designed to encourage sober friends to safely escort intoxicated 18-20-year-old people home).
- 7) Separate applications must be submitted for each identified community in which services are proposed.

Failure to meet any of the above eligibility criteria and requirements will cause the application to be deemed ineligible.

3.0 AWARD INFORMATION

Total Anticipated Available Funding: \$1,230,000

Anticipated Number of Awards: Minimum of 10 awards

Anticipated Award Amount: Up to \$123,000 per year

Length of Project: Up to 4 years

Applications will be reviewed and ranked according to the evaluation criteria outlined in Section 13.0.

Applicants must submit a budget summarizing the attributed costs for this project and complying with the terms outlined in this RFA. Applicants should complete the Budget Template provided in Attachment A. Proposed budgets cannot exceed \$123,000 in total costs in any year of the proposed project for proposals that include alcohol and one additional target substance. Annual funding will be available contingent on funding availability, performance, fiscal management, quality management, outcomes and data submission.

As noted in Section 5, applicants must commit a full-time (1.0 FTE) position to this project.

5.0 SCOPE OF WORK

Overarching Intent and Expectation

To meet the goals of the SPF-PFS project, grantees are **required to use the Strategic Prevention Framework (SPF) process at the community level** to: assess needs (Step 1); build capacity (Step 2); engage in a strategic planning process (Step 3); implement a comprehensive, evidence-based prevention approach (Step 4); and evaluate implementation and related outcomes (Step 5).

The funding is designed to support grantees that commit to the following **broad principles**:

- 1) **community mobilization** focused primarily on **implementation of environmental management strategies**; and,
- 2) restricting access through increased <u>collaboration with law enforcement agencies</u>. (if applicable)

Grantees will be expected to:

- Designate a full-time (1.0 FTE) grant coordinator position for alcohol and either electronic vapor product (e-cigarettes) or marijuana work for this project
- Develop and demonstrate an understanding of local conditions pertaining to underage drinking, electronic vapor product (e-cigarettes) or marijuana use to support the scope of the proposed project application.
- Develop and demonstrate the ability to plan and mobilize their community to address local conditions relevant to substances targeted in the proposal.
- Develop a comprehensive action plan with a primary focus on evidence-based environmental management strategies; including but not limited to: addressing underage access to alcohol (harm reduction approaches are not permitted under the terms of this funding, (see Eligibility and Requirements).
- Implement a comprehensive environmental management approach which includes evidencebased programs, policies and practices that address substances targeted in the proposal;
- Create a sustainability plan with options for fundraising as necessary;
- Participate in technical assistance and training related to the SPF-PFS grant.
- Include related expenses in the project budget (ex. Local or statewide meetings and conferences, all anticipated travel expenses, and other necessary costs related to implementing proposed project activities.
- Include in the budget travel expenses to attend a one-day grantee meeting in Raleigh once per year.
- Utilize data to create and implement a Health Disparities Plan related to the target substances
 that: 1) identifies service area, sub-populations (i.e. racial, ethnic, sexual/gender minority
 groups) vulnerable to disparities and 2) implement strategies targeted to the identified group(s)
 to decrease disparities in alcohol (electronic vapor product or marijuana) use rates among these
 subpopulations.

5.1 PROGRAMMATIC REQUIREMENTS AND PRIORITIES

As stated in the Purpose, this project will support projects that address the identified target substances and youth and young adults at the community level.

All project activities must comply with the design and framework outlined in this RFA. Additionally, the Rev. 03.15.16

contractor shall adhere to the budget and proposed timeline submitted as part of this application.

5.2 CONTRACTOR RESPONSIBILITIES

The North Carolina SPF-PFS will be primarily focused on preventing alcohol use of individuals aged 9 to 20 through strategic planning and implementation of environmental management strategies (Optional: Electronic Vapor (e-cigarette) Products or Marijuana for individuals 9 and above).

- A. Have affiliation with a host organization (e.g., an organization with 501(c)(3) or NC non-profit status) and be able to receive federal funds.
- B. Must include a focus on underage (ages 9 through 20) alcohol use. Applicants may also choose (OPTIONAL) to include one additional area of focus including electronic vapor (ecigarette) product use or marijuana use (ages 9 and above), depending on local needs and demonstrated readiness to address the issue. Please note that focusing on more than one substance does not necessarily mean that an application will be scored higher.
- C. Must agree to measure and report outcomes, established and approved by PFS Evaluators and the Division of Mental Health, Developmental Disabilities and Substance Abuse Services (DMHDDSAS). Applicants must demonstrate the ability to comply with the PFS National Cross Site evaluation requirements.
- D. 5.3 PERFORMANCE STANDARDS AND EXPECTATIONS

5.4 REPORTING REQUIREMENTS

- A. DMH will provide any necessary reporting templates to the Contractor within 30 days of their due date.
- B. Quarterly Reporting Requirements
 - a. Contractor shall provide quarterly status reports, using a template provided by DMH, which will outline Contractor activity/progress on activities outlined in the project proposal and timeline.
 - b. Elements of the quarterly reports shall include:
 - i. Names and status of individuals serving as staff.
 - ii. Identification of community partners involved with the project.
 - iii. Relevant assessment data to support initiatives and progress on completion.

iv. Summary of current challenges and barriers.

- v. Summary of successes.
- vi. Anticipated next steps and completion dates.
- c. By the fifteenth (15th) of each month, the contractor shall submit an invoice for allowable expenditures from the preceding month, and copies of back-up documentation (receipts, travel logs, and timesheets/HR documentation).

C. Ad-hoc

- a. Contractor shall submit ad hoc reports required under this contract, including those as a part of Health Disparities, Sustainability, and Evaluation, or also requested by the Department.
- b. DMH shall work with Contractors to establish reasonable deadlines for all ad-hoc reports.

D. Annual:

a. Contractor agrees to attend and provide a 20-minute report on activities and "successes and barriers" once per year, which will occur in Raleigh at the end of Year 1.

E. Other:

- a. Contractor agrees to comply with any additional reporting requirements required by SAMHSA during the course of this grant.
- b. DMH shall work to ensure any federal reporting requirements introduced does not create duplicative reporting with existing DMH reporting forms.

F. Annual Site Visits

a. Contractor agrees to report on required documents and deliverables for the grant.

5.5 OTHER CONTRACTOR REQUIREMENTS

Program staff working under this award agree to work collaboratively and in good-faith with DMH identified training and technical assistance for this grant.

5.6 CONTRACTOR QUALIFICATIONS AND CAPACITY

Qualified applicants for this RFA are limited to LME-MCOs, community-based organizations, and coalitions in good standing with the Department. Applicants shall:

- Have been providing services in North Carolina for one year prior to the submission of this proposal.
- Provide a clear organization/collaboration chart that shows structure and management detail.
- Be able to describe the community's existing resources and any previous or current efforts to address the identified problems discussed in the Assessment section. Include any developing or established efforts in this description.
- Be able to describe the community partners that will participate in this project. Include a
 description of the partner's current area(s) of focus. If you are an ATOD prevention agency and
 there is an ATOD prevention focused collaborative or coalition in your proposed service area,
 you must include a MOU to work collaboratively with this group. If you are an ATOD prevention
 focused collaborative or coalition and there is an ATOD prevention agency in your proposed
 service area, you must include a MOU to work collaboratively with this agency.
- Be able to describe any training or other capacity building activities needed by any of the involved entities to ensure the success of this project.

5.7 CONTRACTOR ENHANCEMENTS OR ADDITIONAL CONSIDERATIONS

6.0 DIVISION RESPONSIBILITIES

DMH shall:

- Monitor the Contractor's performance through reporting and communication mechanisms outlined within this RFA.
- Provide for training and technical assistance, and evaluation to support this project.
- Reimburse the Contractor as described in "Reimbursement" below.
- Provide all reporting templates to the Contractor.
- Provide additional technical assistance as needed or requested to comply with the terms of this contract.

6.1 Performance Oversight

Division and Contractor shall hold a semi-annual briefing at a mutually agreeable time. In each of these meetings, the Division and Contractor will assess the Contractor's progress and identify both positive trends and any difficulties experienced in meeting the terms of the contract.

If the Division determines that the Contractor's inability to comply with the terms of the contract can be addressed or remediated through changes in the Contractor's practices, the Division may require the Contractor to develop a corrective action plan for addressing areas of noncompliance.

In addition to quarterly briefings, the Division will assess Contractor's performance 30 days prior to the end of the first year and provide written feedback on the Contractor's first year performance to inform the Contractor's approach to activities performed in the second year.

The Division may elect to terminate this contract if it determines the Contractor cannot adequately satisfy the terms of this contract for any reason.

7.0 TERM OF CONTRACT, OPTIONS TO EXTEND

The performance period for this contract begins on October 1, 2019 and ends September 30, 2023. Up to two possible option years may be exercised by mutual agreement in accordance with the Terms and Conditions.

8.0 BUDGET

The RFA/ line item budget shall constitute the total cost to the Division for complete performance in accordance with the requirements and specifications herein, including all applicable expenses such as administrative cost. Contractor shall not invoice for any amounts not specifically allowed for in the line item budget of this RFA.

The Contractor shall use the Cost Table found in ATTACHMENT F: Line Item Budget to create the Line Item Budget and Budget Narrative. The Vendor shall not use any other tables or forms, nor modify the contents of any of the shaded cells in the Cost Table.

All costs provided in Line item budget must be firm and fixed for the duration of the contract, which could last as long as three years if the State exercises its option for one additional year.

9.0 INVOICING AND REIMBURSEMENT

- 1. Activities provided under this contract must be separate and distinct from any activities for which the Contractor receives or seeks reimbursement through it capitated or state-funded payments.
- 2. The contractor shall submit a monthly invoice for based on expenditures by the 15th of the month for services rendered the month prior. The Contractor's invoice shall be on the Contractor's letterhead and shall incorporate an invoice template that the Division shall provide within 10 business days of the Contract's execution date.

10.0 THE SOLICITATION PROCESS

The following is a general description of the process by which agencies or organizations will be selected to complete the goal or objective.

- 1) RFAs are being sent to prospective agencies and organizations.
- 2) Written questions concerning the RFA specifications will be received until the date specified on the cover sheet of this RFA. A summary of all questions and answers will be posted on the RFA web site.
- 3) Applications will be received from each agency or organization. The original must be signed and dated by an official authorized to bind the agency or organization.
- 4) All applications must be received by the funding agency not later than the date and time specified on the cover sheet of the RFA. Faxed applications will not be accepted.
- 5) At that date and time the applications from each responding agency and organization will be logged in.
- 6) At their option, the evaluators may request additional information from any or all Contractors for the purpose of clarification or to amplify the materials presented in any part of the application. However, agencies and organizations are cautioned that the evaluators are not required to request clarification: therefore, all applications should be complete and reflect the most favorable terms available from the agency or organization.
- 7) Applications will be evaluated according to completeness, content, experience with similar projects, ability of the agency's or organization's staff, cost, etc. The award of a grant to one agency and organization does not mean that the other applications lacked merit, but that, all facts considered, the selected application was deemed to provide the best service to the State.
- 8) Agencies and organizations are cautioned that this is a request for applications, and the funding agency reserves the unqualified right to reject any and all applications when such rejections are deemed to be in the best interest of the funding agency.

11.0 GENERAL INFORMATION ON SUBMITTING APPLICATIONS

1) Award or Rejection

All qualified applications will be evaluated and awards made to those agencies or organizations whose capabilities are deemed to be in the best interest of the funding agency. The funding agency reserves the unqualified right to reject any or all offers if determined to be in its best interest. Successful Contractors will be notified by September 30, 2019.

2) Decline to Offer

Any agency or organization that receives a copy of the RFA but declines to make an offer is requested to send a written "Decline to Offer" to the funding agency. Failure to respond as

requested may subject the agency or organization to removal from consideration of future RFAs.

3) Cost of Application Preparation

Any cost incurred by an agency or organization in preparing or submitting an application is the agency's or organizations sole responsibility; the funding agency will not reimburse any agency or organization for any pre-award costs incurred.

4) Elaborate Applications

Elaborate applications in the form of brochures or other presentations beyond that necessary to present a complete and effective application are not desired.

5) Oral Explanations

The funding agency will not be bound by oral explanations or instructions given at any time during the competitive process or after awarding the grant.

6) Reference to Other Data

Only information that is received in response to this RFA will be evaluated; reference to information previously submitted will not suffice.

7) Titles

Titles and headings in this RFA and any subsequent RFA are for convenience only and shall have no binding force or effect.

8) Form of Application

Each application must be submitted on the form provided by the funding agency, which will become the funding agency's Performance Agreement (contract).

9) Exceptions

All applications are subject to the terms and conditions outlined herein. All responses will be controlled by such terms and conditions. The attachment of other terms and condition by any agency and organization may be grounds for rejection of that agency or organization's application. Funded agencies and organizations specifically agree to the conditions set forth in the Performance Agreement (contract).

10)Advertising

In submitting its application, agencies and organizations agree not to use the results therefrom or as part of any news release or commercial advertising without prior written approval of the funding agency.

11) Right to Submitted Material

All responses, inquiries, or correspondence relating to or in reference to the RFA, and all other reports, charts, displays, schedules, exhibits, and other documentation submitted by the agency or organization will become the property of the funding agency when received.

12)Competitive Offer

GENERAL TERMS AND CONDITIONS

Relationships of the Parties

Independent Contractor: The Contractor is and shall be deemed to be an independent contractor in the performance of this contract and as such shall be wholly responsible for the work to be performed and for the supervision of its employees. The Contractor represents that it has, or shall secure at its own expense, all personnel required in performing the services under this agreement. Such employees shall not be employees of, or have any individual contractual relationship with, the Division.

Subcontracting: The Contractor shall not subcontract any of the work contemplated under this contract without prior written approval from the Division. Any approved subcontract shall be subject to all conditions of this contract. Only the subcontractors specified in the contract documents are to be considered approved upon award of the contract. The Division shall not be obligated to pay for any work performed by any unapproved subcontractor. The Contractor shall be responsible for the performance of all of its subcontractors.

Assignment: No assignment of the Contractor's obligations or the Contractor's right to receive payment hereunder shall be permitted. However, upon written request approved by the issuing purchasing authority, the State may: (a) Forward the Contractor's payment check directly to any person or entity designated by the Contractor, or (b) Include any person or entity designated by Contractor as a joint payee on the Contractor's payment check. In no event shall such approval and action obligate the State to anyone other than the Contractor and the Contractor shall remain responsible for fulfillment of all contract obligations.

Beneficiaries: Except as herein specifically provided otherwise, this contract shall inure to the benefit of and be binding upon the parties hereto and their respective successors. It is expressly understood and agreed that the enforcement of the terms and conditions of this contract, and all rights of action relating to such enforcement, shall be strictly reserved to the Division and the named Contractor. Nothing contained in this document shall give or allow any claim or right of action whatsoever by any other third person. It is the express intention of the Division and Contractor that any such person or entity, other than the Division or the Contractor, receiving services or benefits under this contract shall be deemed an incidental beneficiary only.

Services

Service Standards: During the term of the Agreement the Contractor and its employees, agents, and subcontractors shall provide high quality professional services consistent with the standards of practice in the geographic area and with all applicable federal, state, and local laws, rules and regulations, all applicable ethical standards, and standards established by applicable accrediting agencies. The Contractor and its employees, agents and subcontractors shall exercise independent professional judgment in the treatment and care of patients.

Records: During the term of this Agreement, the Contractor and its employees, agents, and subcontractors shall maintain complete and professionally adequate medical records consistent with the standards of practice in the geographic area and their respective health care professions. The Contractor and its employees, agents, and subcontractors shall prepare all reports, notes, forms, claims and correspondence that are necessary and appropriate to their professional services.

 - The Contractor is not required to provide and maintain automobile liability insurance on any vehicle owned, hired, or non-owned -- unless the vehicle is used in the performance of this contract.
- (b) The insurance coverage minimums specified in subparagraph (a) are exclusive of defense costs.
- (c) The Contractor understands and agrees that the insurance coverage minimums specified in subparagraph (a) are not limits, or caps, on the Contractor's liability or obligations under this contract.
- (d) The Contractor may obtain a waiver of any one or more of the requirements in subparagraph (a) by demonstrating that it has insurance that provides protection that is equal to or greater than the coverage and limits specified in subparagraph (a). The Division shall be the sole judge of whether such a waiver should be granted.

- (e) The Contractor may obtain a waiver of any one or more of the requirements in paragraph (a) by demonstrating that it is self-insured and that its self-insurance provides protection that is equal to or greater than the coverage and limits specified in subparagraph (a). The Division shall be the sole judge of whether such a waiver should be granted.

In that event, all finished or unfinished deliverable items prepared by the Contractor under this contract shall. at the option of the Division, become its property and the Contractor shall be entitled to receive just and equitable compensation for any satisfactory work completed on such materials, minus any payment or compensation previously made. Notwithstanding the foregoing provision, the Contractor shall not be relieved of liability to the Division for damages sustained by the Division by virtue of the Contractor's breach of this agreement, and the Division may withhold any payment due the Contractor for the purpose of setoff until such time as the exact amount of damages due the Division from such breach can be determined. In case of default by the

Contractor, without limiting any other remedies for breach available to it, the Division may procure the contract services from other sources and hold the Contractor responsible for any excess cost occasioned thereby. The filing of a petition for bankruptcy by the Contractor shall be an act of default under this contract.

Waiver of Default: Waiver by the Division of any default or breach in compliance with the terms of this contract by the Contractor shall not be deemed a waiver of any subsequent default or breach and shall not be construed to be modification of the terms of this contract unless stated to be such in writing, signed by an authorized representative of the Department and the Contractor and attached to the contract.

Availability of Funds: The parties to this contract agree and understand that the payment of the sums specified in this contract is dependent and contingent upon and subject to the appropriation, allocation, and availability of funds for this purpose to the Division.

Force Majeure: Neither party shall be deemed to be in default of its obligations hereunder if and so long as it is prevented from performing such obligations by any act of war, hostile foreign action, nuclear explosion, riot, strikes, civil insurrection, earthquake, hurricane, tornado, or other catastrophic natural event or act of God.

Survival of Promises: All promises, requirements, terms, conditions, provisions, representations, guarantees, and warranties contained herein shall survive the contract expiration or termination date unless specifically provided otherwise herein, or unless superseded by applicable Federal or State statutes of limitation.

Compliance with Applicable Laws

Amendment: This contract may not be amended orally or by performance. Any amendment must be made in written form and executed by duly authorized representatives of the Division and the Contractor. Travel Expenses: Reimbursement to the Contractor for travel mileage, meals, lodging and other travel expenses incurred in the performance of this contract shall not exceed the rates published in the applicable State rules. International travel shall not be reimbursed under this contract.

Sales/Use Tax Refunds: If eligible, the Contractor and all subcontractors shall: (a) ask the North Carolina Department of Revenue for a refund of all sales and use taxes paid by them in the performance of this contract, pursuant to G.S. 105-164.14; and (b) exclude all refundable sales and use taxes from all reportable expenditures before the expenses are entered in their reimbursement reports.

Advertising: The Contractor shall not use the award of this contract as a part of any news release or commercial advertising.

Conflict of Interest Policy Example

The Board of Directors/Trustees or other governing persons, officers, employees or agents are to avoid any conflict of interest, even the appearance of a conflict of interest. The Organization's Board of Directors/Trustees or other governing body, officers, staff and agents are obligated to always act in the best interest of the organization. This obligation requires that any Board member or other governing person, officer, employee or agent, in the performance of Organization duties, seek only the furtherance of the Organization mission. At all times, Board members or other governing persons, officers, employees or agents, are prohibited from using their job title, the Organization's name or property, for private profit or benefit.

- A. The Board members or other governing persons, officers, employees, or agents of the Organization should neither solicit nor accept gratuities, favors, or anything of monetary value from current or potential contractors/vendors, persons receiving benefits from the Organization or persons who may benefit from the actions of any Board member or other governing person, officer, employee or agent. This is not intended to preclude bona-fide Organization fund raising-activities.
- B. A Board or other governing body member may, with the approval of Board or other governing body, receive honoraria for lectures and other such activities while not acting in any official capacity for the Organization. Officers may, with the approval of the Board or other governing body, receive honoraria for lectures and other such activities while on personal days, compensatory time, annual leave, or leave without pay. Employees may, with the prior written approval of their supervisor, receive honoraria for lectures and other such activities while on personal days, compensatory time, annual leave, or leave without pay. If a Board or other governing body member, officer, employee or agent is acting in any official capacity, honoraria received in connection with activities relating to the Organization are to be paid to the Organization.
- C. No Board member or other governing person, officer, employee, or agent of the Organization shall participate in the selection, award, or administration of a purchase or contract with a vendor where, to his knowledge, any of the following has a financial interest in that purchase or contract:
 - 1. The Board member or other governing person, officer, employee, or agent;
 - 2. Any member of their family by whole or half blood, step or personal relationship or relative-in-law;
 - 3. An organization in which any of the above is an officer, director, or employee;
 - 4. A person or organization with whom any of the above individuals is negotiating or has any arrangement concerning prospective employment or contracts.
- D. **Duty to Disclosure** -- Any conflict of interest, potential conflict of interest, or the appearance of a conflict of interest is to be reported to the Board or other governing body or one's supervisor immediately.
- E. **Board Action** -- When a conflict of interest is relevant to a matter requiring action by the Board of Directors/Trustees or other governing body, the Board member or other governing person, officer, employee, or agent (person(s)) must disclose the existence of the conflict of interest and be given the opportunity to disclose all material facts to the Board and members of committees with governing board delegated powers considering the possible conflict of interest. After disclosure of all material facts, and after any discussion with the person, he/she shall leave the governing board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists.

In addition, the person(s) shall not participate in the final deliberation or decision regarding the matter under consideration and shall leave the meeting during the discussion of and vote of the Board of Directors/Trustees or other governing body.

F. Violations of the Conflicts of Interest Policy -- If the Board of Directors/Trustees or other governing body has reasonable cause to believe a member, officer, employee or agent has failed to disclose actual or possible conflicts of interest, it shall inform the person of the basis for such belief and afford the person an opportunity to explain the alleged failure to disclose. If, after hearing the person's response and after making further investigation as warranted by the circumstances, the Board of Directors/Trustees or other governing body determines the member, officer, employee or agent has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.
