Subject: New Work First Funding Allocations Reported on the XS411 Report

Effective with September 2003 services paid October 2003, the number of Work First Funding Allocations reported on the XS411 report will reduce from five (5) to two (2). WF Adm. Federal, WF Adm. State, WF Ser Federal, WF Ser State and WF Adm. Local will become obsolete funding allocations. WF Federal and WF State will become the two <u>new</u> WF funding allocations.

The WF Federal funding allocation will be available to all 100 counties and the WF State funding allocation will be available to the nine "electing" counties and the two Indian counties.
