Effective with October 2007 services reimbursed November 2007, you will need to use the following revised additional code to claim the reimbursement for the Work First Demonstration Grant "Child & Family Enrichment Services" on the DSS-1571.

Part IA (Services and Fringe Benefits): (No change) The Part I coding will be tracked as two application codes. Application code 137 for service cost titled WF Demo On Job Training Svc and another application code 332 administrative (admin) costs titled WF Demo On Job Training Adm. The service cost, application code 137 will be accessible to counties with Function Code 54, Column 13. The admin cost will be tracked in application code 332. Application code 332 admin cost will accumulate [similar to how cost are tracked with Function 03, Col. 11 for application codes 358 & 341] as they appear in the XS325 report. These applications are 100% Federal funds.

Part II (Administrative Expenditure and/or Purchased Services): These application codes are 100% Federally funded.

**Part IV** (**Purchase Services**): (*No change*) Counties will need to use **Fund ID** "U" with the applicable Work First Demonstration On Job Training Services code that is to be purchased. Cost will be tracked in application code 137 (WF Demo On Job Training Svc).

The CFDA number is 93.558 for the *Work First Demo Grant* fund. The Allocated cost from application codes 332, 137, 138, 139, 141, 142 and **143** will be tracked on the XS411 under the heading *WF Demo*. In terms of overhead (for your Maximus software) these program will <u>not</u> draw overhead from IM Supervision & Clerical, IV-D Supervision & Clerical or Joint Workers IM & IV-D.
