## Subject: Fiscal Reporting Procedures regarding Food and Nutrition Employment and Training Able-Bodied Adults Without Dependents reimbursement; reactivation of codes

Effective beginning <u>August 2016</u> for services reimbursed <u>September 2016</u>, Brunswick 010. Buncombe 011. Durham 032. Johnston 051. Mecklenburg 060, and Orange 068 Counties will need to use the following codes to claim reimbursement for FS Employment and Training ABAWD on their DSS-1571 report. *These codes are codes that have been reactivated.* 

## Part IA: (Service- Salary and Fringe Benefits)

Application Code 472, Function Code 11, Column 16, FS Employment and Training ABAWD FS E&T ABAWD 100% Federal funds

Part II: (Administrative Expenditures and/or Purchased Services) There is <u>no</u> Part II coding requirements.

**Part IV: (Purchased Services requiring client ID)** Counties will need to use **Fund ID** "S" with the applicable service code for the *FS E&T ABAWD*. The service codes for the **ABAWD as it pertains to scholarship/education & training** <u>are available in the</u> <u>SIS Manual</u>. These purchased services are to be documented with a client identification number. Cost will be tracked in application code **472** *FS E&T ABAWD* 

The CFDA number for this fund is 10.561. **FS Employment and Training ABAWD** is a capped allocated fund but costs for application code 472 will not be tracked on the DSS XS411c report; although, counties will be provided a funding authorization for the program.

In terms of overhead for the application code in your NCCoReLS software, this program will <u>not</u> draw overhead from Income Maintenance Supervision & Clerical, IV-D Supervision & Clerical or Joint IM & IV-D Workers.
