Subject: Fiscal Reporting Procedures regarding the Community Response Program

Dear County Director of Social Services:

We have <u>activated</u> the following code for costs reported on the DSS-1571 report effective beginning <u>July 2016</u> services reimbursed <u>August 2016</u>. The following counties (Alamance, Catawba, Durham, Henderson, Iredell, Rutherford, Wake, and Wilson) may claim costs as it relates to the **Community Response Program** on the DSS-1571 report using the reporting procedures listed below.

Part IA: Service - Salary and Fringe Benefits

Part I coding application code136 under the title Comm Response Pgm Function 06, Column 10, this application is funded as a 100% federal share.

Part IV: Purchased Services Requiring Client ID Counties will need to use **Fund ID** "C" with the applicable service code for the **Community Response Program**. The service code for **Community Response Program** is available in the SIS Manual. These purchased services are to be documented with a client identification number. Costs will be tracked as **Comm Response Pgm** *in application code 136*.

The CFDA number for this fund is 93.556. The related costs for the new application code 136 "Community Response Program" will not be tracked on the XS411 report. In terms of overhead for application code 136 in your NC-CoReLS software, this program will <u>not</u> draw overhead from Income Maintenance Supervision & Clerical, IV-D Supervision & Clerical or Joint IM & IV-D Workers.
