Subject: Fiscal Reporting Procedures regarding Non-Emergency Medical Transportation (NEMT)

Dear County Director of Social Services:

The following reporting requirements will be for all counties with a <u>February 2018 services</u> reimbursed <u>March 2018</u> date to access the <u>Non-Emergency Medical Transportation Non-Reimbursable</u> code. We are <u>activating</u> this application code for all counties including NAM counties to report on the DSS-1571 report.

Part IA: (Service- Salary and Fringe Benefits)

Application Code 517, Function Code 09, Column 18, Medical Tra Non-Reim. 100% County funds.

Part II: (Administrative Expenditures and/or Purchased Services)

The following codes will be traced in application code 518; the percentage distribution for this activity will be 100% County funds.

Code	Fund	Description
518	4	Medical Veh Non-Reim

Part IV: (Purchased Services requiring client ID)

There are no Part IV coding requirements.

Non-Emergency Medical Transportation is not an allocated capped fund; thus, costs for application codes 517 and 518 will not be tracked on the DSS XS411c report.

In terms of overhead for the application code in your NC-CoReLS software, this program will <u>not</u> draw overhead from Income Maintenance Supervision & Clerical, IV-D Supervision & Clerical or Joint IM & IV-D Workers.
