Subject: DSS Fiscal Manual Updates/Changes

The DSS Fiscal Manual has been reissued with the date of September 30, 2011. The reissued DSS Fiscal Manual replaces all past issuances of the DSS Fiscal Manual. The DSS Fiscal Manual is available to local DSS personnel via the DHHS Office of the Controller website. In addition, copies of the most important correspondence (e.g. Dear County Director letters and Dear Child Support Enforcement Agency Directors letters) are posted on our website for your convenience for viewing or downloading.

The following is a brief summary of the updates/changes made to this fiscal manual reissue.

- 1) The coding for Child and Family Teams Non-IV-E and Child and Family Teams IV-E was deleted.
- The coding for State Adult Protective Services was deleted. Based on fiscal requirements, Adult Protective Services-SSBG coding was added as a replacement. The Part I, Part II, and Part IV reporting criteria, which did not change, can be found in sections III A, III B, and III C respectively.
- The coding for CPS Expansion IV-E and CPS Expansion State was deleted. Based on fiscal requirements, CPS (TANF TO SSBG) was added to replace CPS Expansion State. The Part I reporting criteria, which did not change, can be found in section III A.

- 4) The coding for Job Boost Admin and Job Boost Admin Non Reimbursable was deleted.
- 5) The coding for TANF Contingency Job Boost Phase II svc and TANF Job Boost Phase II adm was added. The Part I and Part IV reporting criteria can be found in section III A, and III C.
