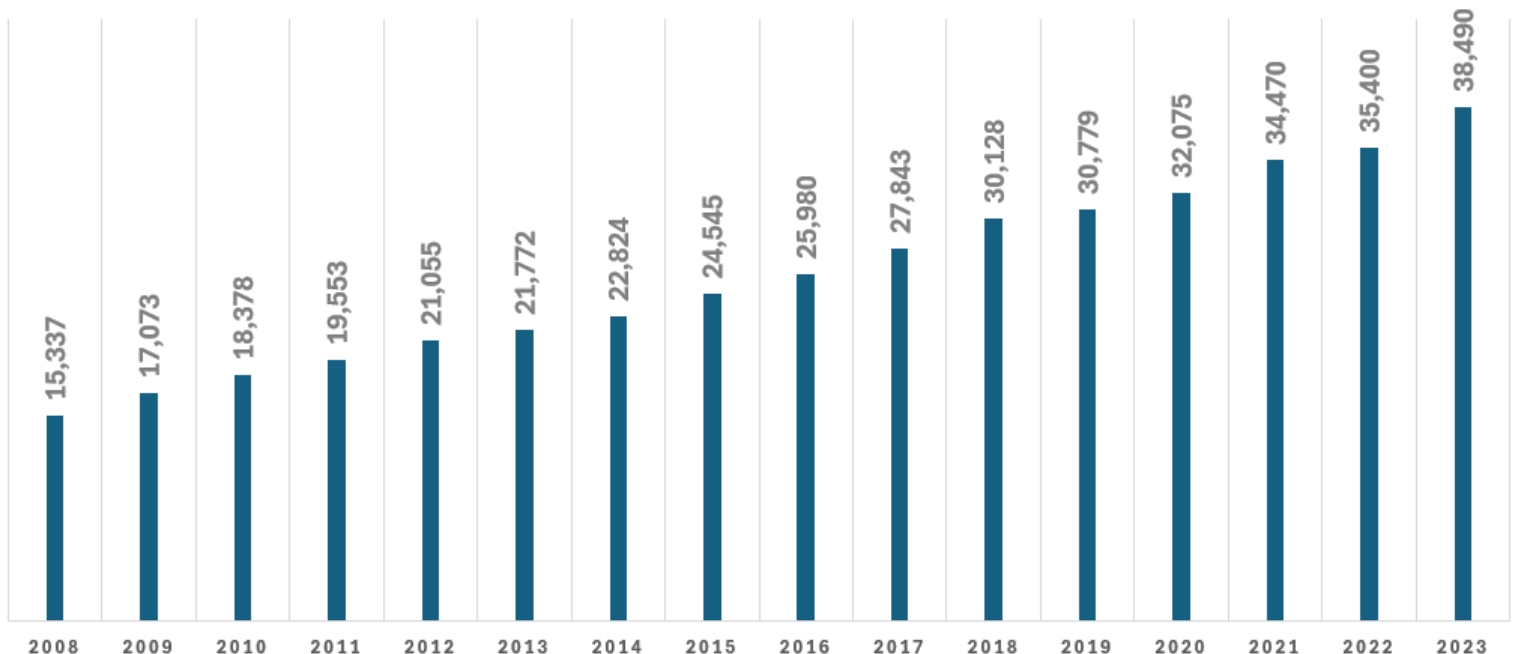
ADULT PROTECTIVE SERVICES

Adult Protective Services (APS) in North Carolina, under the legal framework of General Statute 108A, is dedicated to safeguarding disabled and vulnerable adults. This statutory service, administered by County Departments of Social Services, evaluates reports of abuse, neglect, and exploitation affecting disabled adults. APS aims to ensure such adults are free from maltreatment. However, the funding for these services is limited and often depleted early in the state's fiscal year, with counties supporting the primary financial responsibility.

The most recently available NC 2022 Aging Profile shows that NC is the 9th most populated state in the United States with 17.5% of the population being over age 65. Steady increases in the aging population are projected through 2042. As vulnerable populations increase, it is anticipated that APS needs will continue to increase. 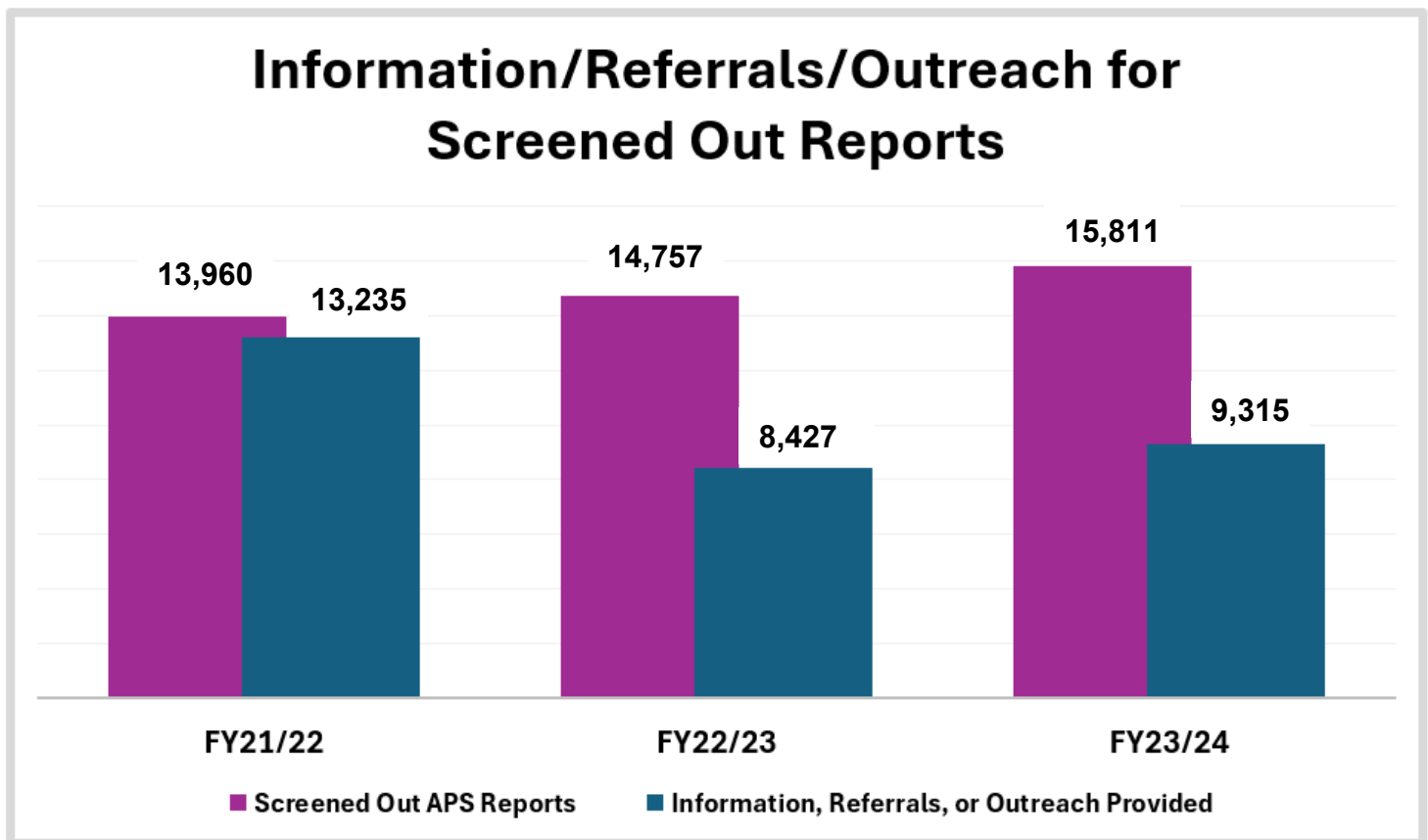
- There has not been a notable change in the number of APS evaluations conducted on individuals who have had prior APS interventions.

ADULT PROTECTIVE SERVICES INFORMATION & OUTREACH

Reports for Adult Protective Services (APS) are submitted to the 100 County Department of Social Services across North Carolina. These reports are reviewed based on the criteria outlined in N.C. General Statute 108A. For an APS referral to proceed, it must meet three key conditions:

1. Involvement of a disabled adult,
2. Allegations of abuse, neglect, or exploitation,
3. A need for protective services.

If a report does not meet any of these criteria, it is not pursued further under APS. However, alternative assistance can be provided, such as offering information, referrals, or outreach services. Information and referrals may include connecting the individual to other agencies or informing them of available community resources. Outreach efforts could involve home visits or telephone contacts to gather additional information and provide support or resources as needed.



NC counties provided information, referrals, or face-to-face outreach visits to 9,315 individuals in SFY 23/24.

The reflected decrease in citizens served reflects efforts to improve accuracy in SFY23/24 to ensure DSS-5027s accurately reflected open/closed cases. Discrepancies highlight the ongoing need to ensure accuracy on the DSS-5027 reports.

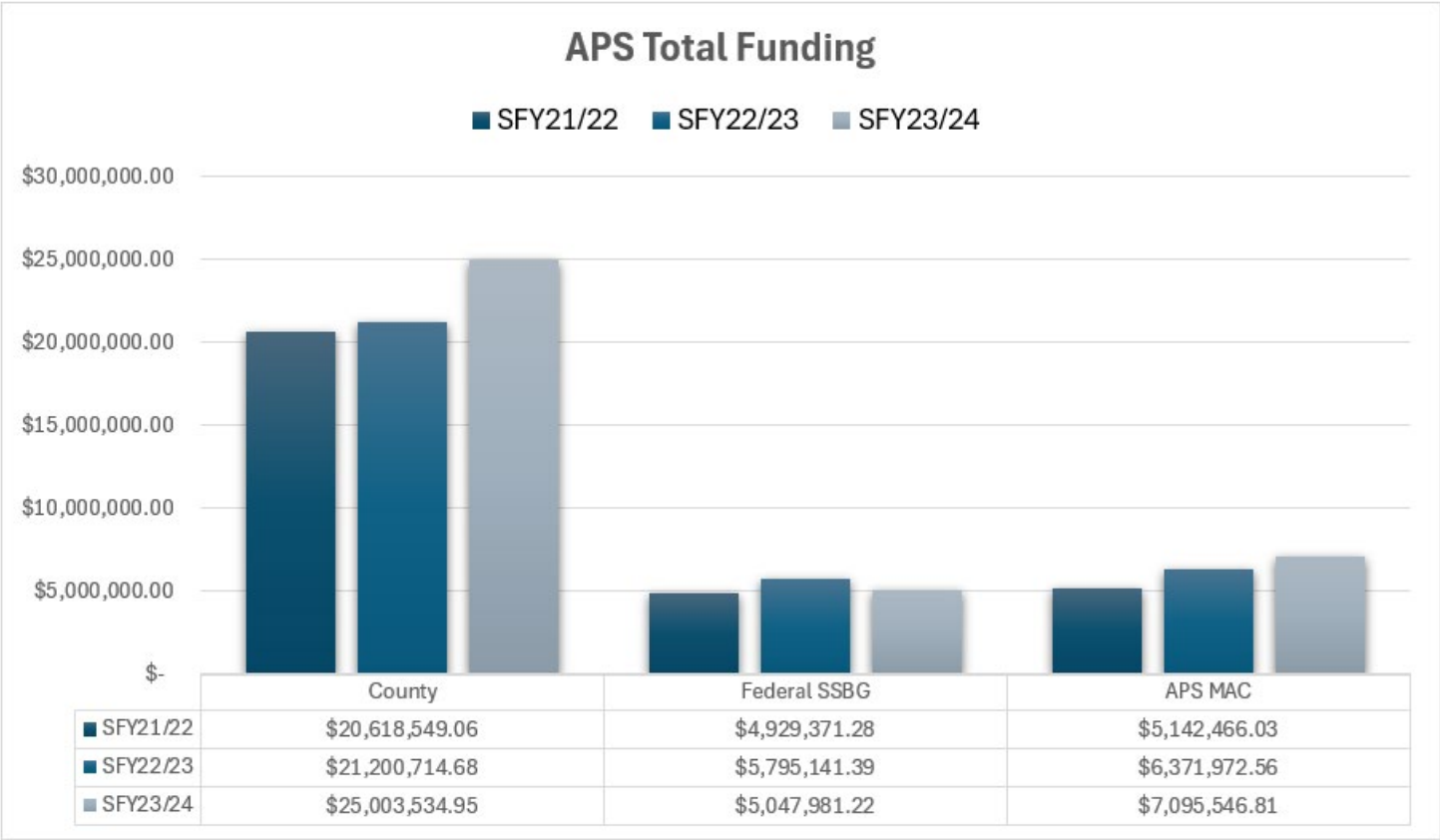

ADULT PROTECTIVE SERVICES FUNDING

Adult Protective Services (APS) is partially funded through the federal Social Services Block Grant (SSBG), which supports various programs within County Departments of Social Services (DSS). However, SSBG funding is limited and must be shared across multiple services, leading many counties to exhaust their allocations by the midpoint of the fiscal year. Once depleted, counties must use local funds to sustain this legally mandated service.

In state fiscal year 2021–2022, Medicaid Administrative Claiming (MAC) was introduced as a new funding source to support APS in counties. MAC allows counties to receive federal reimbursement for administrative activities that assist Medicaid-eligible individuals. This funding model, which provides an uncapped 50 percent federal match with a required 50 percent county contribution, has already offered meaningful financial relief by helping offset APS operational costs.



APS ESSENTIAL SERVICES FUNDING

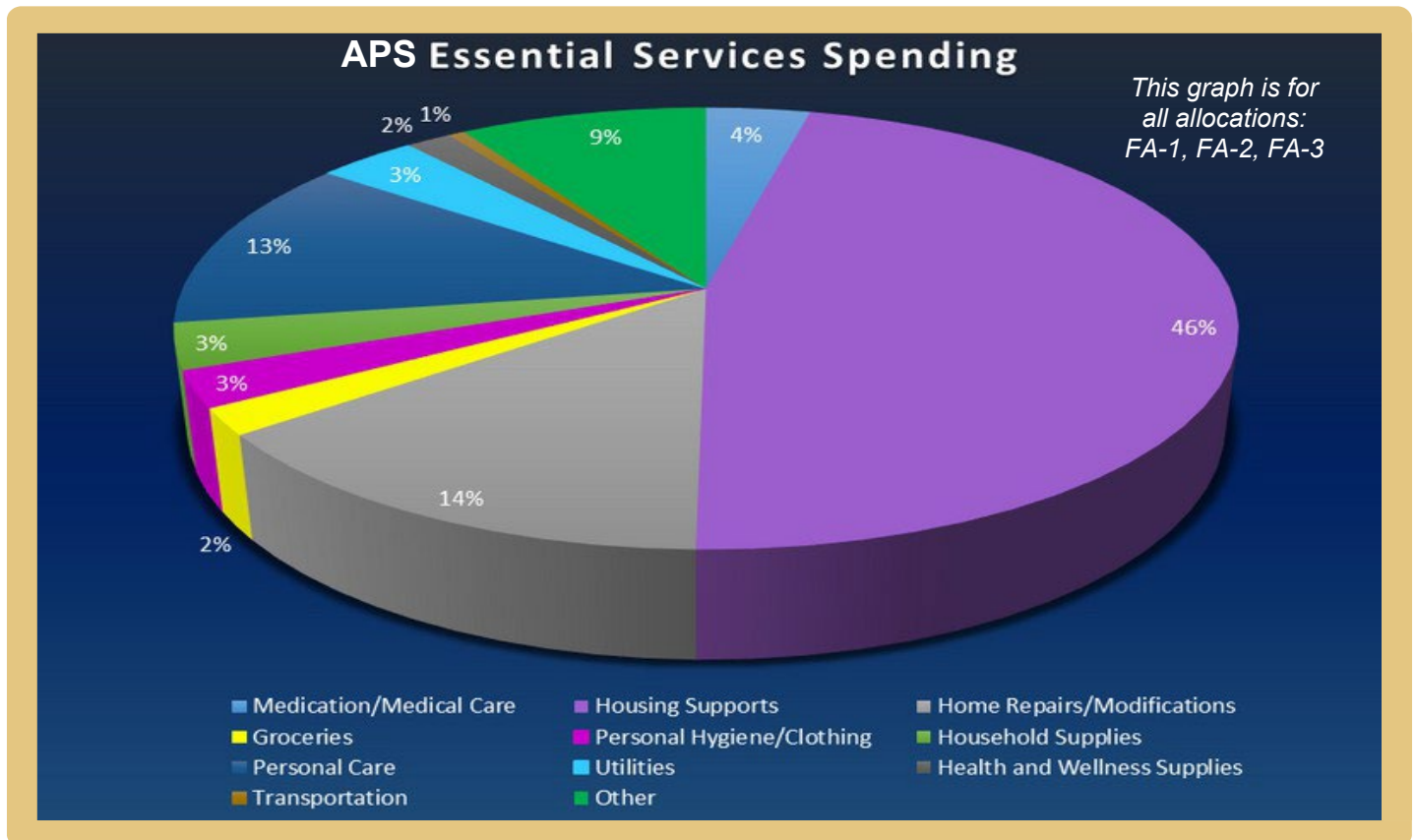
The APS Essential Services Fund was a non-recurring allocation established through the 2021 American Rescue Plan Act (ARPA). An initial Funding Authorization (FA), FA-1, of \$1,500,000 was provided for February 1, 2022 – December 31, 2022 to help County Departments of Social Services address critical protective service needs, particularly in situations where local funding and resources were limited.

This fund supported essential services delivered under Protective Services for Adults Planning and Mobilizing Services (SIS Code 204). Covered services included medical care for physical and mental health, personal hygiene assistance, access to food and clothing, heated and ventilated shelter, protection from health and safety hazards, and safeguards against abuse, neglect, and exploitation.

Due to significant utilization of the initial allocation, two additional non-recurring allocations were issued:

- **FA-2:** \$528,699 distributed during State Fiscal Year (SFY) 2022–2023, covering January through June 2023.
- **FA-3:** \$1,000,000 disbursed at the start of SFY 2023–2024, covering July 2023 through June 2024.

As with the initial allocation, these subsequent funds were intended to support, not replace, existing county resources for APS. The APS Essential Services Fund was designed as a temporary solution to assist counties in meeting the urgent needs of vulnerable adults involved in APS. After June 2024, there were no additional designated funding sources for APS Essential Services.

DSS GUARDIANSHIP

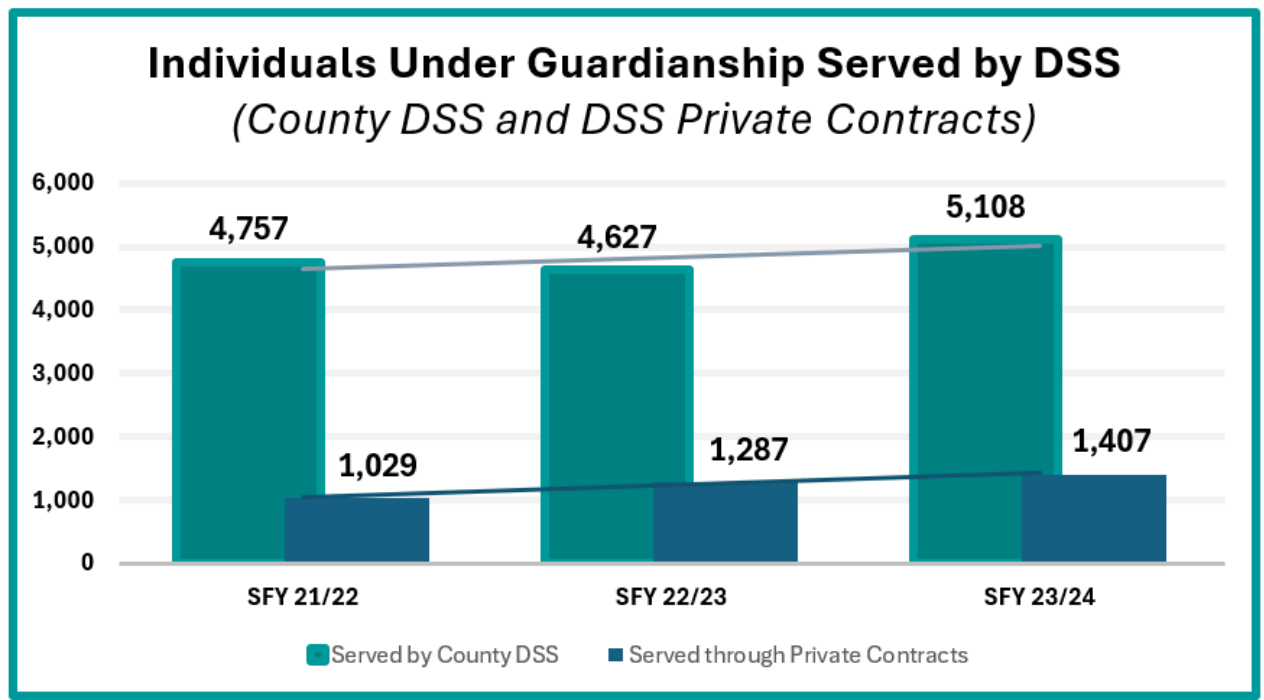
Adult guardianship in North Carolina is governed by General Statute Chapter 35A. County Departments of Social Services (DSS) Directors are the only statutorily designated Disinterested Public Agent Guardians (DPAGs). DSS Directors may be appointed as guardians for individuals adjudicated incompetent when no willing or appropriate family member or other support is available. Once appointed, the guardian is responsible for making decisions in the best interest of the individual regarding their person and/or estate.

In SFY 23/24, county DSS agencies served **6,515** individuals under public guardianship, including **1,407** individuals through county DSS private contracts with private guardianship service providers.

As noted earlier in this report, North Carolina's aging population continues to grow, with projections indicating sustained increases through 2042. This demographic trend is expected to drive continued growth in guardianship service needs, as illustrated in the accompanying graphs. 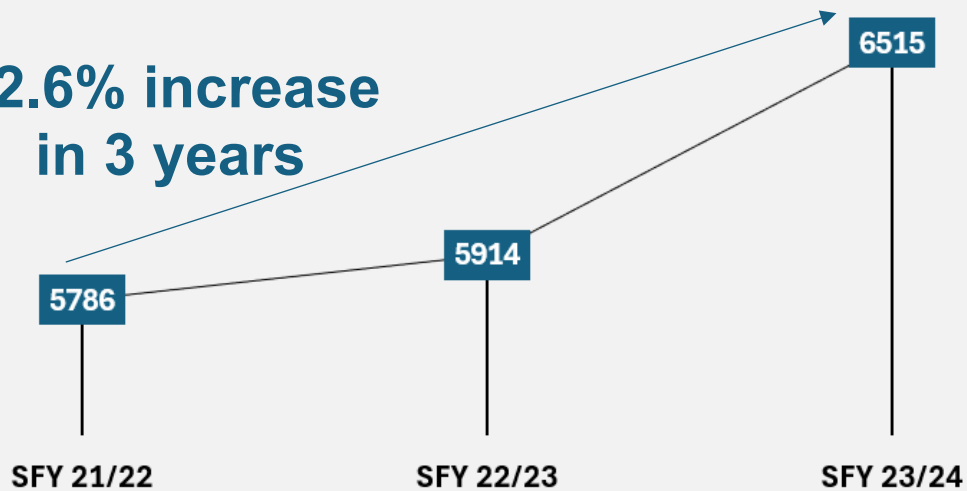

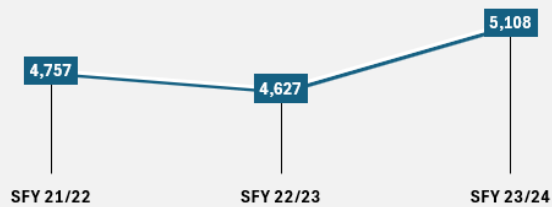

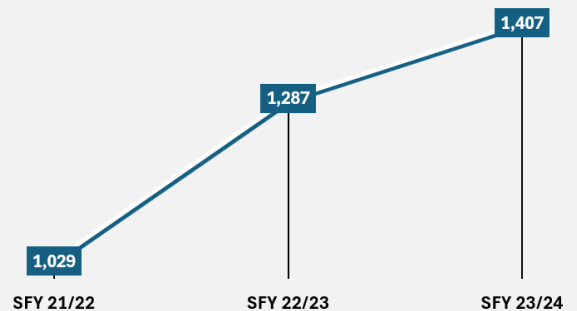

GUARDIANSHIP FUNDING

Guardianship services are funded in part through the Social Services Block Grant (SSBG); however, these funds are often exhausted early in the county fiscal year, requiring counties to rely on local resources to sustain the program. As a statutorily mandated service, guardianship plays a critical role in protecting some of the state’s most vulnerable adults. Counties have reported a [245% increase](#) in funding needs for guardianship services since State Fiscal Year 2021–2022, reflecting the growing demand for this essential support.

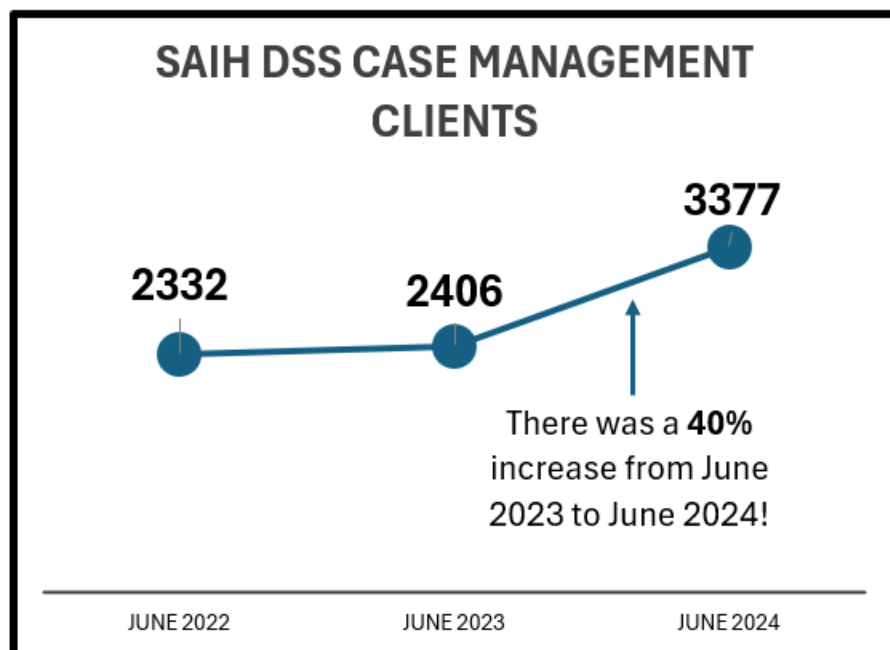


SPECIAL ASSISTANCE IN-HOME

The Special Assistance In-Home (SAIH) program provides a cash supplement to low-income individuals who are at risk of entering residential care but prefer to remain in their own homes. In addition to financial assistance, the program offers supportive services that help individuals safely maintain independence in the community. County Departments of Social Services case managers conduct comprehensive assessments to evaluate the factors that may affect an individual's ability to remain at home and determine the appropriate level of support. As of the close of State Fiscal Year 2023–2024, a total of **5,266** individuals were receiving SAIH services in North Carolina.

As noted earlier in this report, North Carolina is the ninth most populous state, with 17.5 percent of its population over the age of 65, according to the 2022 North Carolina Aging Profile. The older adult population is projected to grow steadily through 2042, which will likely contribute to increased demand for supportive services such as SAIH. 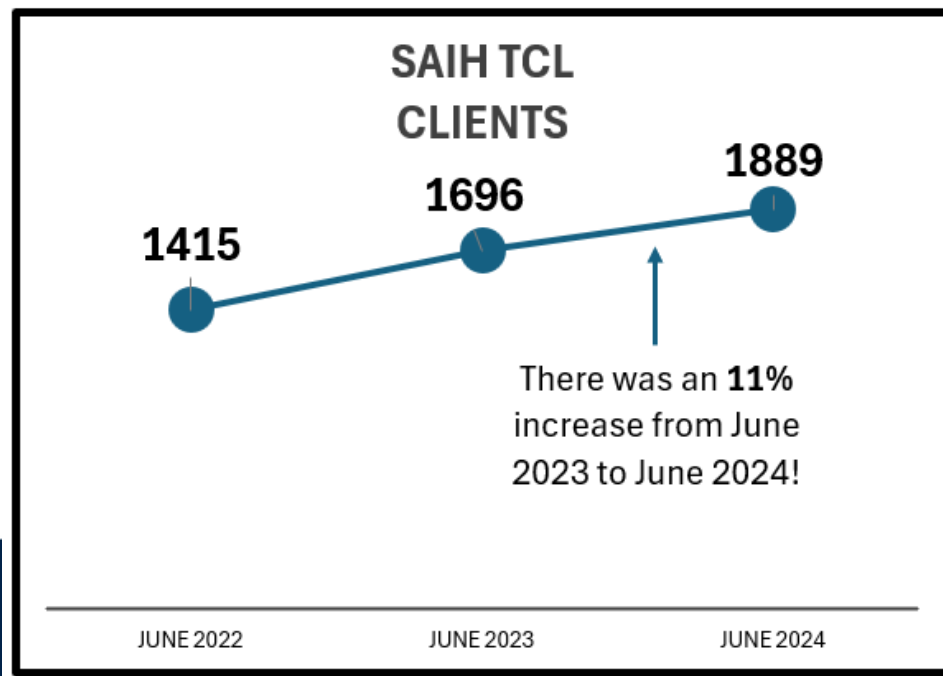
TCL RECIPIENTS RECEIVING SAIH

In 2012, the State of North Carolina entered into a settlement agreement with the U.S. Department of Justice (DOJ) to address the inappropriate institutionalization of individuals with serious mental illness (SMI). Under the agreement, the state committed to developing and implementing effective measures to ensure that individuals with SMI receive necessary services and supports in the most integrated setting appropriate, as identified through person-centered planning. This includes individuals currently residing in or at risk of entering an adult care home (ACH).

This agreement led to the creation of the Transitions to Community Living (TCL) initiative, which supports individuals with SMI in transitioning from institutional settings to community-based living. One of the key public services available to eligible individuals within the TCL program is the Special Assistance In-Home (SAIH) program. SAIH provides financial assistance and support to help individuals live independently in their communities.

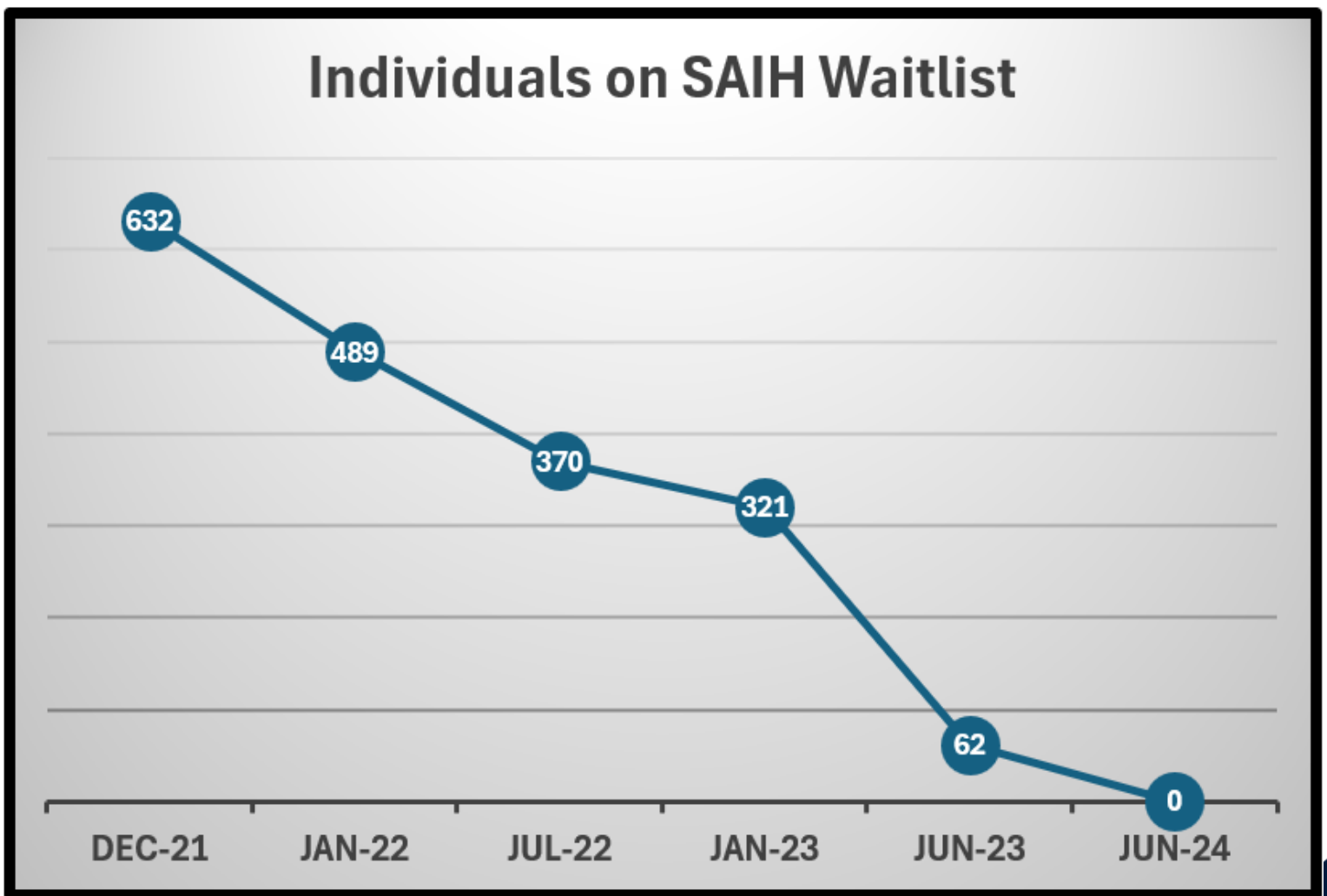
Managed Care Organizations (MCOs) play a central role in the TCL initiative by providing case management services to individuals receiving SAIH through this program.

As of June 2024, a total of **1,786** individuals were receiving SAIH services as part of the TCL initiative under MCO case management.



SAIH WAITLIST

North Carolina County Departments of Social Services have worked diligently since December 2021 to eliminate waitlists for the Special Assistance In-Home (SAIH) program. This effort was in direct response to requirements outlined in Session Law (S.L.) 2021-180, which called for the removal of waitlists to ensure equitable access to in-home supports for eligible individuals. As of this report, 100 percent of counties have successfully eliminated their SAIH waitlists, ensuring compliance with the law and expanding access to critical services that support individuals in remaining safely in their homes and communities.



ADULT SERVICES TRAINING

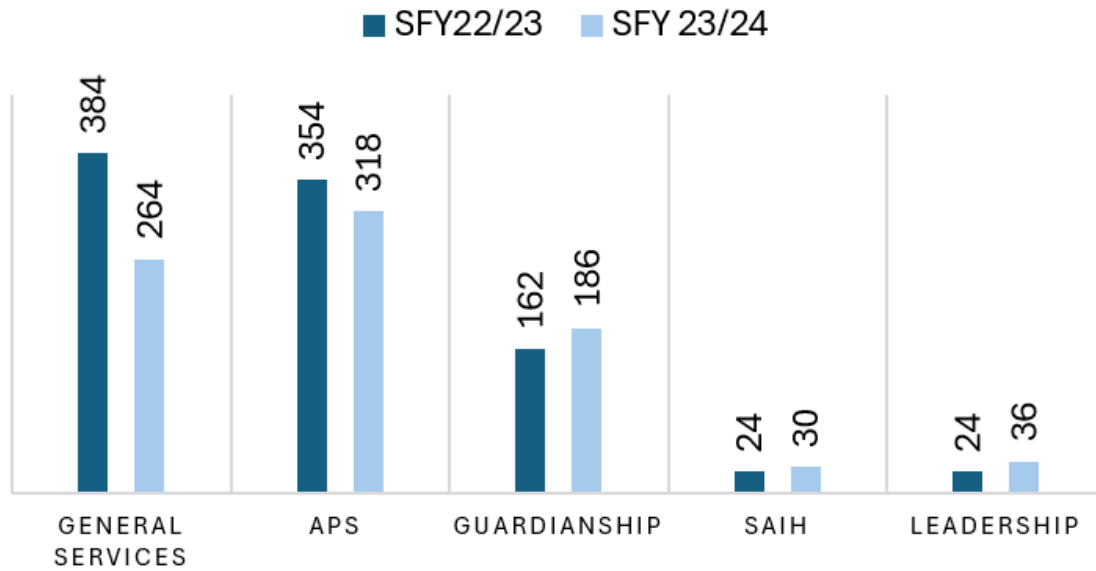
In FY22/23 NC DHHS Adult Services implemented a Learning Management System (LMS). Since its launch, NC DHHS Adult Services has steadily expanded training offerings, increasing the number of instructor-led courses from 12 to 16—a **33% increase**— providing more opportunities for hands-on learning and interaction. Additionally, eLearning options grew from 23 to 25 courses, reflecting an **8.7% increase**, allowing for greater flexibility and accessibility. These improvements reflect our commitment to enhancing learning opportunities and supporting participants in their professional development.

The NC DHHS LMS has had a **63.7% increase** in user participation, growing from 1,630 users last year to 2,668 this year.

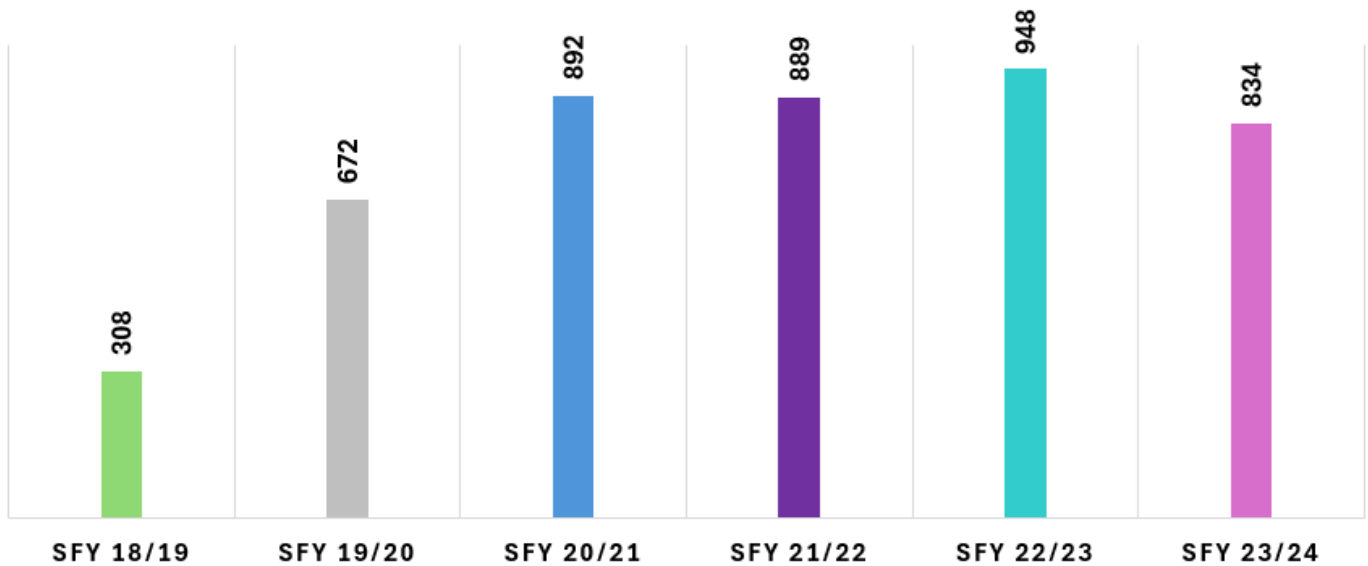

In FY 2022–2023, **NC DHHS Adult Services** continued to expand both instructor-led and eLearning training opportunities. However, **delivered training hours for APS and General Services decreased**, primarily due to lower registration rates despite the broader availability of training offerings.

ADULT SERVICES STAFFING

Adult Services Social Workers in County Departments of Social Services play a critical role in supporting vulnerable adults in their communities. These professionals manage programs in Adult Protective Services, Guardianship, SAIH, and Case Management, providing protective services, resources, and interventions to prevent abuse, neglect, and exploitation. They work closely with clients, families, and community partners to ensure safety and well-being, often managing complex cases that require a deep understanding of social, legal, and health issues. Their dedication is essential to safeguarding the rights and dignity of adults in need of care and protection. Adequate staffing is critical to ensure that the caseload requirements can be fulfilled. The following data shows a global picture for staffing Adult Services in North Carolina:

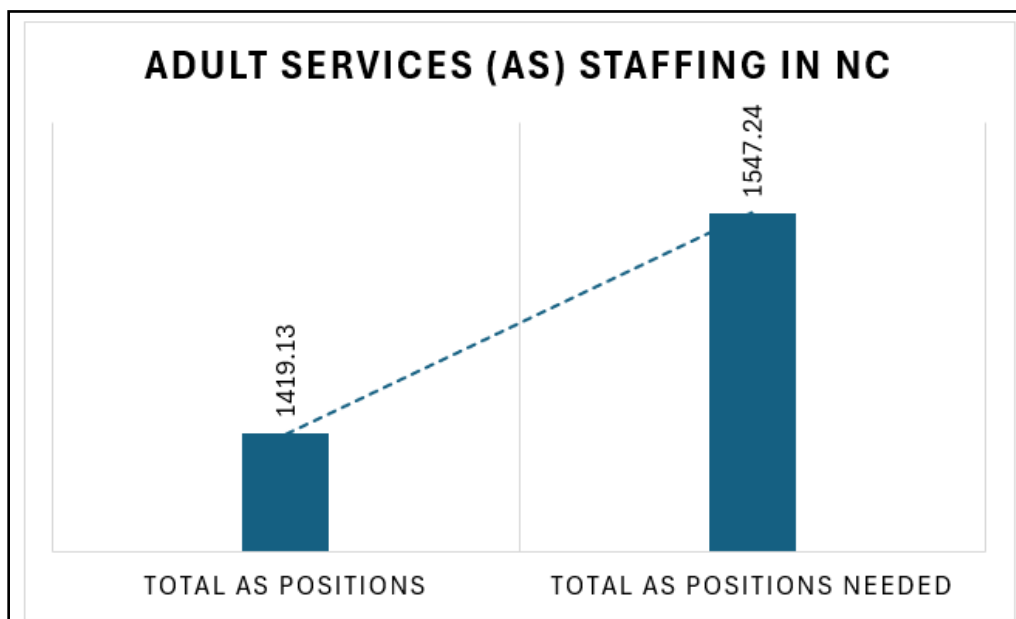

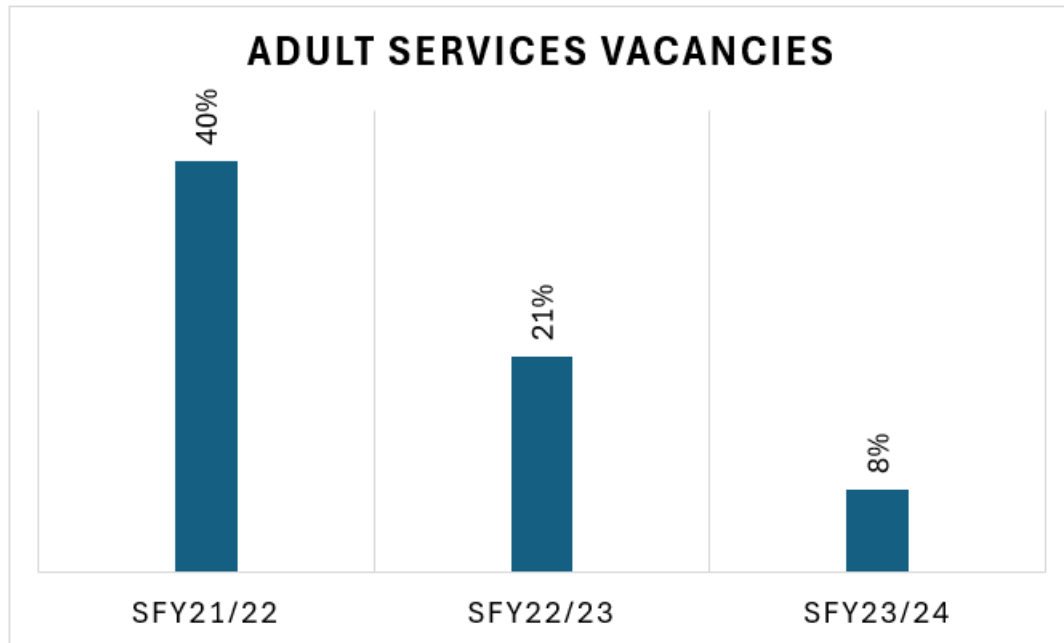

The data presented above indicates that North Carolina has a critical need for Adult Services social workers, with a staffing deficit of 128.11 positions required to achieve full staffing levels and meet established caseload recommendations.





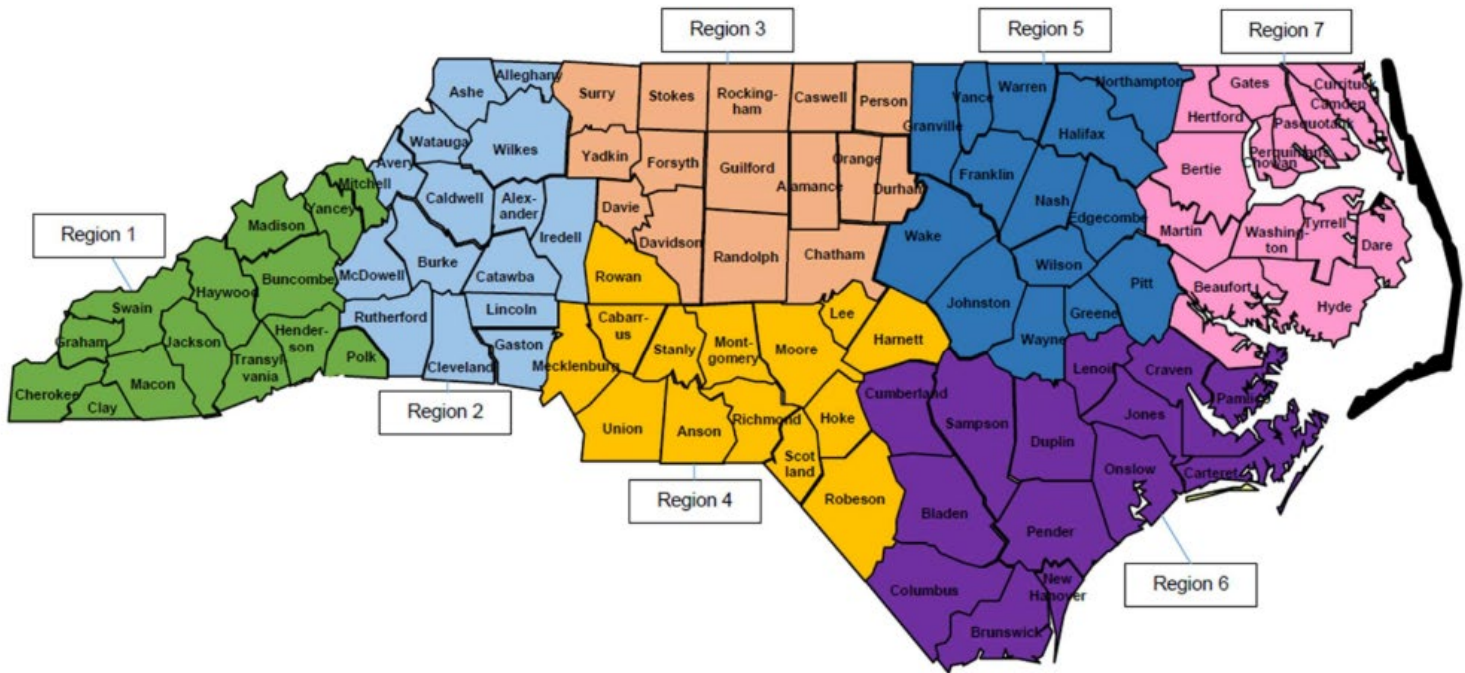
While the chart above illustrates a statewide decrease in vacancies within NC’s Adult Services programs, the remaining deficit for 128.11 positions that are not budgeted for, coupled with the significant growth across all Adult Services programs, underscores an unprecedented need for additional resources and support.

Ensuring adequate staffing levels within North Carolina’s Department of Social Services is essential to maintaining manageable caseloads and supporting social workers in delivering quality services and ensuring safety for vulnerable and disabled adults in NC.

MULTIDISCIPLINARY TEAMS (MDTs)

Statewide Expansion and Support Efforts:

Multidisciplinary teams (MDTs), also known as interdisciplinary teams, consist of professionals from diverse disciplines working collaboratively toward common goals. Each team member contributes their specialized knowledge and expertise to develop coordinated responses and comprehensive solutions. MDTs are particularly effective in addressing complex issues such as adult maltreatment by fostering collaboration, promoting innovation, and supporting informed decision-making.

Recognizing the value of this approach, the North Carolina Department of Health and Human Services (NC DHHS) Adult Services has set a statewide goal to establish MDTs in all 100 counties by June 2025. To support this initiative, DHHS Adult Services has partnered with the UNC School of Government (UNC SOG) to provide resources and tools that assist counties in designing, implementing, and sustaining MDTs. These resources include training materials, ongoing consultation, and a dedicated Help Desk for individualized support. Progress and Successes: SFY 2023–2024

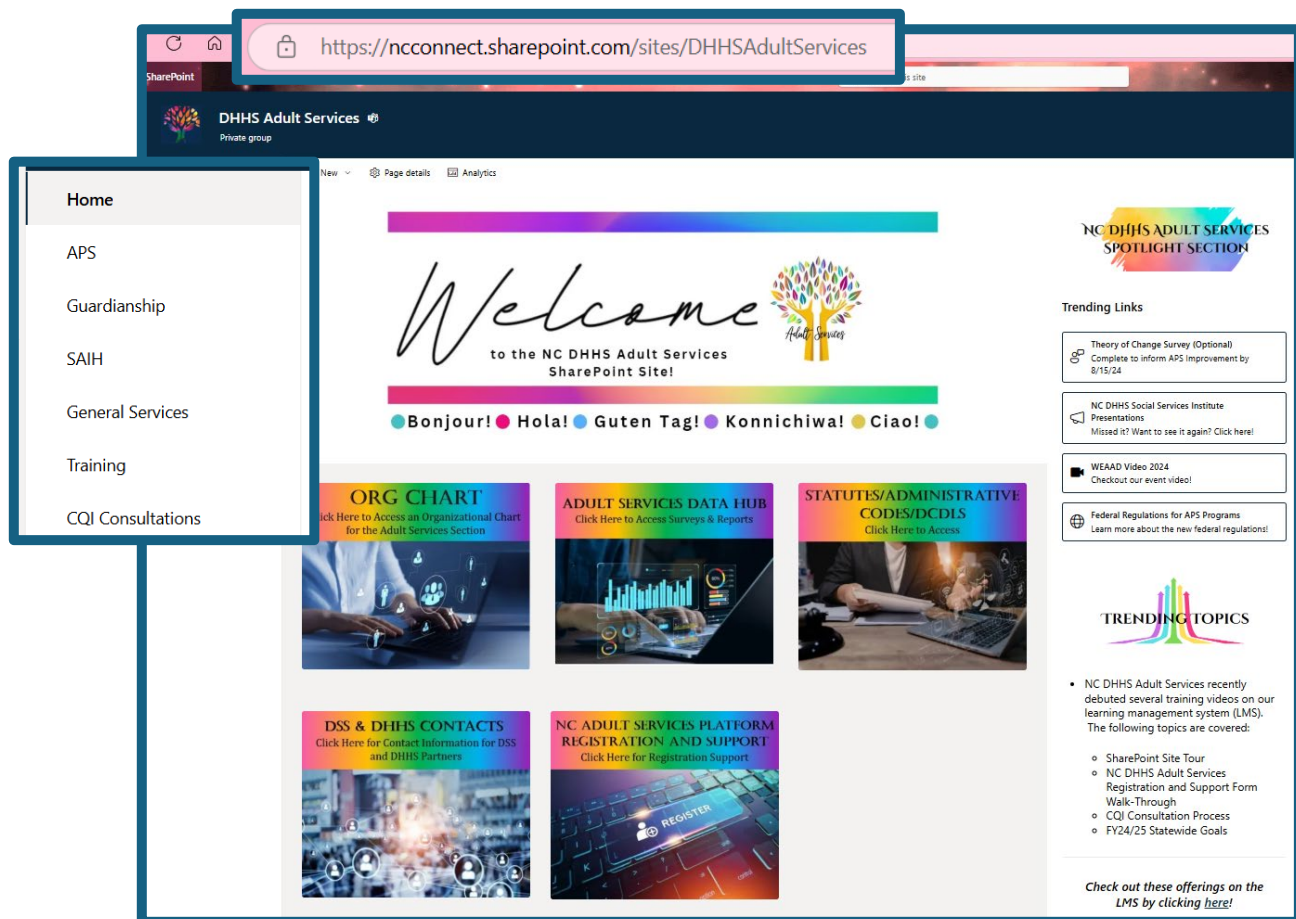
- **County Expansion:**
In SFY 2023–2024, the number of counties with established MDTs increased from 31 to 51, representing a [46% growth](#). This expansion enhances cross-agency collaboration and strengthens the ability to protect vulnerable adults statewide.
- **Help Desk Support:**
Through the APN Help Desk, [93 counties](#) received assistance in SFY 2022–2023 to support the development or maintenance of MDTs.
- **County Progress:**
As of June 30, 2024, [34 counties](#) have made measurable progress toward forming an MDT. These counties are at various stages, ranging from initial discussions to being nearly ready for launch.
- **Direct Engagement:**
In SFY 2023–2024, the APN Director attended and facilitated [8 MDT meetings](#), providing strategic support and problem-solving assistance.
- **Consultation Services:**
The APN Director offered on-site, virtual, or telephone consultation to [44 counties](#). An additional 20 counties were supported through email consultations addressing a variety of MDT-related topics.
- **Training and Networking:**
[8 counties](#) sent representatives to the inaugural *MDT Booster Shot Series* meeting, held in Guilford County on June 25, 2024.

ADULT SERVICES SHAREPOINT

A new SharePoint Site was developed in FY23/24 to enhance access to information and streamline communication to county agencies. The site is organized to be program specific, offering targeted resources and updates for each Adult Services program, such as APS, Guardianship, and SAIH Case Management.

The site has a “no wrong door” approach which ensures users can easily navigate information that they need, regardless of their starting point. The Adult Services SharePoint reflects a commitment to improving service delivery and collaboration within the Adult Services network.

As of December 2024, the SharePoint site had **81,349** cumulative site visits. Since the launch of the platform DHHS Adult Services staff have onboarded **2,203** county DSS team members to the site.

ADULT SERVICES STATEWIDE CONSULTATIONS

Strengthening Collaboration and Practice:

Monthly statewide consultations play a critical role in enhancing Adult Services programs across North Carolina. These sessions support continuous quality improvement by identifying trends, disseminating state policy updates, and collaboratively addressing challenges encountered by County Departments of Social Services (DSS). They also serve as a mechanism for strengthening training initiatives, ensuring consistent knowledge-building and skill development across all regions. This promotes greater uniformity in service delivery statewide.

Importantly, these consultations have significantly improved communication between state and local agencies. They foster the exchange of ideas, strengthen connections, and align efforts toward common goals, driving innovation, efficiency, and excellence in serving vulnerable adults and their communities.

Regional Collaboration and Tailored Support

Each Monthly Statewide Consultation is followed by regional breakout sessions, where participants gather within their seven designated Regional Clusters. These smaller groups provide an opportunity to address local issues more directly and develop region-specific solutions. Teams engage with their Continuous Quality Improvement (CQI) Specialists for tailored guidance and benefit from peer-to-peer exchanges, sharing experiences, effective strategies, and lessons learned. This structure ensures a balance between the advantages of statewide coordination and the need for targeted, community-level support.

Participation and Engagement: SFY 2023–2024 Highlights

- **Peak Attendance:**
The highest participation occurred in February 2024, with [645 attendees](#), reflecting strong interest and engagement among county partners.
- **Monthly Average:**
An average of [458 participants](#) attended each monthly consultation during SFY 2023–2024, underscoring sustained commitment to collaboration, training, and quality improvement across the state.

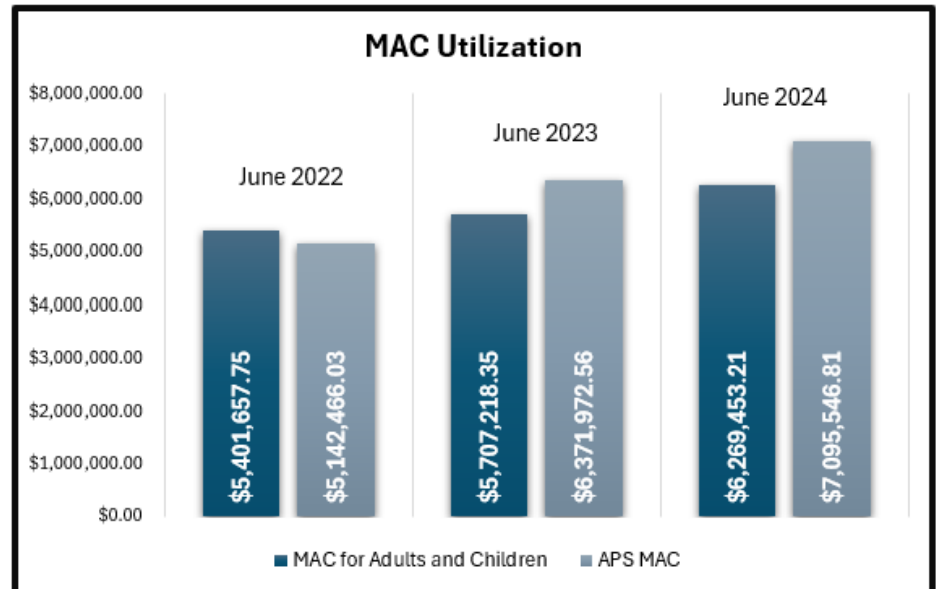
MEDICAID ADMINISTRATIVE CLAIMING (MAC)

Medicaid Administrative Claiming for Adults and Children serves as a funding mechanism that enables County Departments of Social Services to receive reimbursement for the administrative efforts of DSS staff in linking individuals to services outlined in the North Carolina State Plan.

Medicaid Administrative Claiming (MAC) offers essential support to Medicaid-eligible adults and children by assessing their medical and mental health needs that may heighten their risk of negative health outcomes. It also implements strategies aimed at addressing those needs through education on self-care, enhancement of medical treatment, and coordinated care. These approaches are designed to elevate healthcare quality, enhance health outcomes, prevent expensive hospitalizations, and foster the overall well-being of families.

Since July 1, 2021, social workers assisting individuals receiving APS services (SIS Codes 202 and 204) who are current Medicaid beneficiaries can utilize 202 or 204 as the SIS Code and “MAC” as the program code when filling out their day sheets to access MAC funding.
