ORH, the North Carolina Community Health Worker Association (NCCHWA), North Carolina Area Health Education Centers (NC AHEC), Partners In Health (PIH), Community Healing through Activism and Strategic Mobilization CHASM), the University of North Carolina-Pembroke (UNC-P), and the North Carolina Community College System (NCCCS), using developed CHWI principles and values, established a state-wide CHW Association, expanding and standardizing CHW training. CHWs were integrated into teams to support a wide range of health related and social services in communities across NC.ORH and partners continue to take a regional approach to ensure communities across the state are represented. 1089 CHWs certified through NCCHWA: **999** via Standard Core Competency Training (SCCT), **68** via Legacy Track, **22** via Advanced Levels (NCCHWA/UNC-P).
