Crossroads Upgrade 1.35 Conversion of Family Issuance Days 29, 30, 31 to 28

The Crossroads upgrade to version 1.35 eliminates Family Issuance Days (FIDs) of 29, 30, and 31 and contains a conversion of current FIDs of 29, 30 and 31 to an FID of 28. Use this resource to educate staff and participants about the conversion and its impact on First Date to Spend (FDTS) and Last Date to Spend (LDTS).

To avoid overlapping benefits, participants with FIDs of 29, 30 or 31 will continue to have FDTS of 29, 30, 31 the **first month** they are issued benefits in Crossroads 1.35. The subsequent months will have a FDTS of 28. When issuing to participants with FIDs of 29, 30 or 31, use their **Shopping List** to point out the changes in FDTS and LDTS. Make sure to emphasize that the change in LDTS will result in **fewer shopping days for one month**.

Example One:

Participant with FID=29, is issued food benefits on 3/29/25 (Crossroads 1.35)

Example Two:

Participant with FID=29, was issued food benefits on 2/28/25 (Crossroads 1.34)

FDTS	LDTS
2/28/25	3/28/25

The participant comes into clinic at the end of May to get food benefits and now has **FID=28** (Crossroads **1.35**). They will be issued:

5/ 29 /25	6/ 27 /25 instead of 6/28/25 (1 fewer day to redeem benefits)
6/ 28 /25	7/27/25
7/28/29	8/27/25

If the FID=30, there will be 2 fewer days to redeem benefits

If the FID=31, there will be 3 fewer days to redeem benefits If participants with FIDs of 29, 30 or 31 are issued benefits late, or proration applies, the participant will have even fewer days to redeem benefits in the **first month** they are issued benefits in Crossroads 1.35.

Important/Reminders!

The FID should never be changed to avoid proration. For other scenarios, do NOT change the FID unless the family has not been issued benefits in three or more months. **ONLY** change the FID **BEFORE** issuing benefits. If benefits are issued with one FID, then the benefits are voided, FID changed, and benefits reissued, an **overlapping benefits error** will occur.
