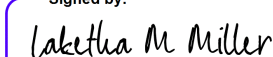
The following revisions/updates have been made to the Fiscal Manual:

- Revision to Section II, page E-2 regarding cover letter format needed for indirect costs allocation plan due April 15, 2026.
- Removal to Section II, pages F-2 through F-53. This was required due to transition from Office of Budget and Management (OMB) Circular A-87 to Code of Federal Regulation Chapter 2 Part 200 which provides new guidance on allowable costs.
