DEAR COUNTY DIRECTOR OF SOCIAL SERVICES for CHILD WELFARE SYSTEM USERS

ATTENTION: CHILD WELFARE PROGRAM ADMINISTRATORS, MANAGERS, SUPERVISORS, AND INTAKE & ASSESSMENT CHILD WELFARE STAFF

SUBJECT: Intake & Assessment Technology System Users and Business Team Partnership Group

REQUIRED ACTION: I Time Sensitive, by September 30, 2022

NC DHHS is committed to implementing a highly usable Child Welfare Information System (CWS) in alignment with the guiding principles (see attached Draft Charter) established through our Joint County/State governance, the Child Welfare System Governance Committee (CWSGC). One approach to achieving this goal is establishing a user group to provide feedback on changes to existing functionality, and input on new features and capabilities. Such a user group has been requested by multiple County DSS Directors, and a proposal for the establishment of this group was presented to the CWSGC this summer with positive feedback. This user group has been titled the "Intake & Assessment Technology Users and Business Team Partnership Group."

The purpose of the Intake and Assessment (I&A) Child Welfare Technology System Users and Business Partnership group is to develop a coordinated approach to recommended improvements to the Child Welfare Technology System for I&A. The group will include key NC DHHS CW Program and Technology program area subject matter experts and NC County DSS system users (including caseworkers, supervisors and/or program managers from across North Carolina).

The HSBIA team is requesting the Directors (or their designee) from each region work together to provide the names, email address and job title/position for the representatives in the workgroup for that region by **September 30, 2022**. The first meeting of this workgroup will be November 9, 8:30-10:30, with ongoing meetings approximately twice per quarter (up to 8 times per year). All meetings will be virtual. Below are considerations for the region as they make their decision for representation.

Participants should include:

- Up to 4 staff per region,
- Regular users of the CWS for Intake and/or Assessments (caseworkers, supervisors or program managers),
- Represent a variety of counties and sizes within the region (when possible),
